Narrative: I received a call from Tommy Razzeca from Moss Landing Harbor Master's office about a diesel spill from a vessel's bilge pump on the Moss Landing Harbor. They recognized the sheen on the water and informed the vessel's owner who was unaware of the spill. They deployed booms right away to contain and capture whatever they can but due to the weather conditions (heavy rain and wind), some of the sheen escaped. I arrived on-site at 2:30 pm to follow-up on the incident, Tommy showed me the vessel that was still in the harbor and the booms that they applied around the spill. Tommy indicated that Harbor Operations and Maintenance staff deployed absorbent pads and sorbent booms in the area to mitigate the spill and that they change the booms periodically and will leave some booms throughout the night to try to collect any additional spill. Harbor staff will collect the used booms and have them properly disposed of as hazardous waste. He also informed me they talked to the boat owner, Mr. Tom Hart, who believes the spill may have been caused by a leak somewhere in the vessel's fuel system which collected in the bilge and eventually pumped out into the harbor. Mr. Hart will take his vessel in for necessary repairs to prevent further discharges the next day. The Harbor Master's office will follow up with the boat owner and ensure the vessel has been repaired before it can dock back in the harbor. I cleared the site at 3 pm.
