### 3. Education and Information

Sabrina Boyce, MPH, Student Ambassador, Center of Expertise on Women's Health, Gender and Empowerment, UC Berkeley School of Public Health

- Study: Looking at the protective and risk factors associated with teen dating violence perpetration among Latinx adolescents in Salinas, CA
- Purpose: to better understand youth violence, sexual health risks, & teen pregnancy
  - Studied 999 youth in Salinas. In CA 11% of urban Latinx 9<sup>th</sup> graders reported in the past year physical DV victimization, In the entire US 31.6% reported perpetration.

- How do we prevent perpetration?
  - Risk factors include social acceptance in the community, witness DV, likely many more
- Findings from 8<sup>th</sup> grade girls
  - Girls perpetration was associated with: Spending less time with friends because of their romantic partner, gang affiliated partner, more frequent alcohol or drug use with a partner.
- Findings from 8<sup>th</sup> grade boys
  - o There were no significant associations.

# This study

- Focus on DV perpetration. Focusing on perpetration vs victimization. Longitudinal focusing on protective factors that reduce risk of DV. Relationship factors not just individual (which the majority of studies are focused on).
  - o Individual Level focused on: Nonviolent problem-solving skills, religiosity.
  - Relationship level focused on: Family cohesion, school connectedness, bullying
- Participants included teenagers that had some form of dating relationship during the time period of the study. It was 52% girls, 48% boys with an approximate age of 13; ½ of them happened to have a parent in the agricultural industry.
- Dating violence was common. 17% reported perpetration at any given timepoint, 6% reported physical violence, 16% psychological or emotional abuse.
- 28% reported perpetration at least once over 2 years, 10% physical, 28% psychological or emotional, 9% both. No significant differences between boys and girls.
- Results: Protective factors found for girls For every additional non-violent problem-solving skill learned, and increased family cohesion developed, there were lowered risk of perpetration. Increased bullying by the participant = increased risk of perpetration between the participant and their partner.
- Family cohesion "familismo" provided buffering effects against female perpetrators but did not seem to affect boys.
- Violence victimization increases risk of perpetrators across multiple forms of violence
- Nonviolent problem-solving skills may reduce risk of bullying which indirectly decreases perpetration of dating violence.

- No statistically significant differences in boys. Different factors associated with boys and girls.
  Boys affirmative response to perpetration of dating violence may have a different meaning
  than girls (their concept of power and control?). The scales used to measure dating violence
  (conflict tactics scale) may have caused a gender bias altering their measurement against
  boys which may have obscured the results.
- The potential implications for Salinas? Safe dates program has been implemented in all but 1 high school. It is showing improvements in conflict resolution skills and anger management. The program also includes parent sessions to improve family communication regarding healthy relationships.
  - Challenge is that boys and girls may have different needs around DV prevention, possibly related to learned gender norms? Genders are mixed in the groups and are both getting same programs. This may have an underlying gender bias or may not be having the same effect on one gender vs. the other.
  - We made need to rethink the approach in school based on this research Dr.
     Deneen Guss
  - It is being seen in the Safe Dates program that the girls are more engaged, and they are feeling more empowered than the boys. – Linda McGlone
- There is not a lot of research out there about perpetration, mostly victimization.
- Future studies: What can we promote? What can we learn from young adults about having healthy relationships?
- Normalization in the Salinas community is making it difficult to report Kenya Burton
- Many women are being reported as the perpetrator when they are actually using selfdefense – Christine Duncan
- Agencies are trying to get the word out to the agricultural workers about this information to let them know they are supported – Herendida Delena
- There is a new pattern of youth who are accepting more of the US culture than their family of origin, which appears to correlate with increasing rates of DV – Sabrina Boyce

COVID Updates and Challenges – update

b. Monterey County: total of 13,280 cases to date, with more cases each day. In the last week and half there have been 80-90 new cases/day, 754 hospitalizations, positivity rate is 13.7%, which is too high to get out of the purple, most restrictive tier. People being hospitalized is mostly 55 years+ and most positive tests are among the younger adults, ages 25-35 – Linda McGlone
