3. Education and Information

Offender Programs 3:55

K. Hanson - CHS offers court and parole ordered DV offender programs, offering classes for women and men separately and noted it is easier to hold participants accountable when probation is supervising participant. If only on court probation, CHS finds the court is slow to respond to the notification of non-attendance. Trend noted: participants are attending but not serious since covid. CHS described requirements to be a facilitator include 40 hr program, 104 hours of shadowing a certified program. CHS looking for more funding to hire facilitators. Lee Garland suggested CHS collaborate with Ohana Project.

Enrique Morales described the offender program at the YWCA is comprised of participants referred from Beh Health & CPS. The Y offers classes in English and Spanish for a 10-week program. The Y is in the process of certification for the court ordered offender program however finding it difficult to find a certified program to shadow. The offender groups at the Y currently have 3 to 8 participants in each class. Enrique and co-facilitator, Marcos Serratos are both Spanish speaking.

C. Duncan stated using the whole family approach includes the offender's needs. Also noted that CHS is unable to help the YWCA complete the shadowing required for certification and many

outside county offender programs have folded or do not offer in-person offender classes. H. Estrada offered to help locate a certified program to shadow.

Marlene Ramirez asked if there are prevention programs in the elementary schools.

MCRCC gives a program to 1st, 3rd, and 6th graders which includes physical, emotional and safe/unsafe touch at the request of any school. MRCC also has "Hear Me Roar". See links:

Hear Me Roar: Coloring Book about consent & Evidence Based DV Prevention Curriculum for elementary school age children.

Lee Garland offers that Beth Shamaz from PG ran a program for youth and their parents 20 yrs ago and could offer support.

It was noted that County Behavioral Health counselors are in the schools.

CHS offers free therapy for non-insured. The YWCA offers therapy with fees based on a sliding scale based on income that includes English/Spanish/Trique (via language line) at the King City DA's Office
