1. Site map: showing all locations which are used, or will be used, to house roosters/hens on property

- 2. Either (a) documentation that applicant has sole legal ownership of the property on which the rooster keeping operation is or will be located or (b) written consent by the owner or owners of the property on which the rooster keeping operation is or will be located to utilize the property for this purpose.
- 3. A manure and solid waste removal management plan describing the method and frequency of manure and solid waste removal and disposal.
- 4. A copy of a Solid Waste Hauling contract, agreement, or invoice (garbage bill) with the county -franchised hauler.
- 5. A Rooster Keeping Operation Permit application fee in the amount of \$315.00. *(Non-refundable even if application is denied or incomplete).*
