- Liz reminded event organizers of the guidelines and requirements for temporary structures.
  - The term temporary structures refer to any tents that will be utilized during a permitted special event.
  - o Tents over 400 square feet will require a permit.
  - General a tent that is less than 400 Square feet will not require a permit.
    - A permit will be required if there will be cooking, lighting, or any type of utility under the tent.
  - The special event questionnaire will be updated to provide additional clarification regarding temporary structures.
  - It is recommended that any application involving tents that will require permits be submitted at least 60 days in advance.
    - A late submittal may be added if the application is not submitted 60 days in advance.
