More pets are in the home than fathers in the U.S. How persons treat their pets can be a red flag for dysfunction and/or DV in the home. 48% of DV victims delay leaving an abusive home for fear of what will happen to the pets. Animals are present 60% on child abuse cases.

Community Agencies care for animals when victim leaves the abusive home.

SPCA operates a Pet Food Bank, free spay/neuter and behavior programs

Meals on Wheels can deliver food for pet as well. Nat'l Coalition and Latham are excellent resources for how to create an animal caregiving program.
