The hearing will be held on **Wednesday, October 26, 2022** at the hour of **9:00 a.m.** This meeting will be held by teleconference to minimize the spread of the COVID-19 virus, in accordance with the State of Emergency proclaimed by Governor Newsom on March 4, 2020, Government Code section 54953 as amended by AB 361, and the County of Monterey Health Officer recommendation of social distancing measures for meetings of legislative bodies.
