Location Fee: \$100

A single business location is defined as a vehicle (car or truck) or a business that can be inspected in one visit. A business that has multiple device types and each device type requires specialized equipment to inspect and necessitates more than one inspection trip, the location may receive a location fee charge for each specialized equipment visited.
