2. Updates & Announcements: -

A. C. Duncan announced that Commission on the Status of Women will collaborate with the YWCA to engage Anna Caballero, CA State Senator and Soledad Mayor Anna Velasquez to recognize the link between DV and Homelessness

- **B.** YWCA will be providing an all-Spanish 40 HR DV Advocate Training in spring 2023 as well as a separate 40 hr DV Advocate training in English.
- **3.** Education: Dawn Allen Probation Director Silver Star 3:50

Silver Star is a Multi-Agency collaborative which focuses on positive youth development.

Truancy mediation, parenting classes, mentoring, substance abuse counseling, anger management, employment skills, are some of the focused programs. Collaborating agencies include Community Human Services: substance abuse for minors 13-18, youth alternate to violence peer to peer counseling, parent & youth support groups. Partners for Peace offer programs for parents and teens, Monterey County Office of Education offer grades 9-12 independent studies, Workforce provide employment skills for up to 24 year olds, CA Youth Outreach for at-risk youth for gang involvement, Sun Street offers substance abuse programs, Harmony at Home provides off-site counseling. Referrals are made through Director Dawn Allen and not only youth on probation are eligible for services. See slides for more info. Restorative Justice Program (Director Jenni Burciaga) provides mediation with a third person (trained mediator) to settle a dispute. Program is voluntary, the parties are met with prior to the face to face mediation. 89% success rate with only 11% recidivism. See attached slides for more info
