SUMMARY OF RECOMMENDATION:

Pursuant to AB 361 and in order for the Commission to continue to meet remotely, the Commission finds: that the COVID-19 pandemic state of emergency declared by Governor Newsom is still in effect; that the Commission has reconsidered the circumstances of the state of emergency; and that the Monterey County Health Officer continues to recommend social distancing measures for meetings of legislative bodies of local agencies.

EXECUTIVE OFFICER'S REPORT:

AB 361

On September 16, 2021, Governor Newsom signed AB 361. This legislation amends the Brown Act to allow meeting bodies subject to the Brown Act to meet via teleconference during a proclaimed state of emergency in accordance with teleconference procedures established by AB 361 rather than under the Brown Act's more narrow standard rules for participation in a meeting by teleconference. AB 361 provides that if a state or local health official recommends social distancing, a "legislative body" – which is defined to include the Commission – may meet remote remotely after September 30, 2021, provided that within 30 days of the first meeting after September 30, and every 30 days thereafter, the legislative body finds 1) the Governor's proclaimed state of emergency is still in effect; 2) the legislative body has reconsidered the circumstances of the state of emergency, and 3) the Monterey County Health Officer continues to recommend social distancing measures for meetings of legislative bodies and/or the state of emergency continues to directly impact the ability of the members to meet safely in person.

The Monterey County Health Officer has recommended and continues to recommend social distancing measures for meetings of legislative bodies, so the Commission was able to meet remotely under AB 361 from October 2021 through January 2023.

The Commission must make the findings at least every 30 days in order to keep meeting remotely. If the Commission makes the findings on January 23, 2023, the Commission may continue to meet remotely for the next thirty days. Due to the greater than 30-day separation between the December 19, 2022 and January 23, 2023 regular meetings of the Commission, the Commission Chair scheduled a special meeting on January 23 – immediately before the January 23 regular meeting – in order to have the opportunity to renew the AB 361 findings again.

Please note that the LAFCO meetings on January 23 will be conducted remotely.

Information Regarding AB 2449

On September 13, 2022, Governor Newsom signed into law AB 2449, which provides an alternative to AB 361 and traditional Brown Act requirements. The new amendments to the Brown Act go into effect on January 1, 2023.

Beginning March 1, 2023, LAFCO meetings will be hybrid with limited options for remote participation by Commissioners. The public will continue to have online and in-person options for participation.

Supervisor Wendy Root Askew has served the last two years as the Alternate County Member Commissioner and was reassigned as a Regular County Member Commissioner at the January 17th Board of Supervisors meeting. Supervisor Glenn Church was newly appointed to serve as a Regular County Member Commissioner. Supervisor Mary Adams was newly appointed to serve as an Alternate County Member Commissioner. Although County appointments are for one year, LAFCO seats have four-year set terms pursuant to the Cortese-Knox-Hertzberg Act. The three County seats on LAFCO have remaining terms that will expire on May 5, 2025.

Article 20, Section 3 of the California Constitution and Government Code Section 1360 requires the taking of an oath upon entering office or being re-appointed to office.

Chair Leffel will administer the oath to Commissioners Root Askew, Church, and Adams who will then take their seats on the Commission.

SUMMARY OF RECOMMENDATION:

EXECUTIVE OFFICER'S REPORT:

Following are current work priorities and a partial list of items that the Commission may consider in coming months or years. It is organized by applications on file, potential applications under discussion, and LAFCO-initiated studies.

Part 1: Items Currently on File and In Progress, but Not Set for Hearing

- 1. Fort Ord Reuse Authority Dissolution: The Fort Ord Reuse Authority (FORA) ceased operations after June 30, 2020. LAFCO's statutory FORA dissolution oversight authority expired after December 31, 2020 with the repeal of the FORA Act, but litigation and monitoring of final administrative tasks will continue into 2023. Staff presented a status report at the August 22 meeting, and will prepare a final resolution for Commission adoption after the litigation and administrative tasks are done.
- 2. Mission Soledad Rural Fire Protection District: Sphere amendment and annexation of Paraiso Springs Resort (portion). Application status is <u>incomplete</u>.

The County approved the Paraiso Springs project in November 2019. The project proponents are now moving forward with development of the site. The previously/historically developed portion of the resort is already within the fire district.

Pursuant to conditions of approval in the County's development permitting, the developer is required to work with the fire district to annex the remainder of the new development site. LAFCO staff has been monitoring and engaged with this project since 2013. LAFCO received the District's application in January 2022. In February 2022, staff issued a completeness review letter listing items needed before the application can be deemed complete. Importantly, the District and developer have signed an agreement to financially mitigate the project's impacts on fire and emergency medical services. Staff continues to coordinate with the District to resolve other items in the completeness letter.

Part 2: Potential Agenda Items under Discussion

1. **City of Gonzales:** Annexation of some or all of an approximately 1,350-acre area placed in the City's sphere in 2014, plus potentially an adjacent 50-acre parcel. Status is <u>pre-application</u>.

The City of Gonzales is currently completing an administrative draft Specific Plan and EIR for the Vista Lucia project (Fanoe-owned lands of approximately 770 acres). The City similarly is working on a specific plan and an EIR for the Puente del Monte project (Jackson and Rianda-owned lands comprising approximately 547 acres). In total, the two projects together would represent a large expansion of the City, approximately doubling the existing City size. The scope of such an expansion raises issues relevant to LAFCO's review. On June 28, 2021, the Commission held a study session to receive information on the status of the City's proposed annexations.

The City issued a Notice of Preparation for the Vista Lucia project in September 2021, and LAFCO staff provided a comment letter in October 2021. LAFCO will comment on the project's draft environmental impact report when it becomes available, probably in 2023. The City anticipates submitting a LAFCO annexation application for the Vista Lucia project in 2023. Also in 2023, we anticipate commenting on a draft environmental impact report for the Puente del Monte project, and receiving an application for annexation of that project. Staff continues to coordinate with Gonzales staff, and with the County, as the City refines and develops these future expansion proposals.

In 2022, City staff discussed other potential annexation/SOI proposals with LAFCO staff. Still in concept status, those proposals may be further refined in coming months or years.



2. Castroville Community Services District – Sphere of influence amendment, interim out-of-agency service extension (wastewater collection services), and annexation of 174 Struve Rd in Moss Landing (Ortega Berry Farms)

The property owners and Castroville CSD are interested in connecting the developed portion of this ag-industrial site to the District's wastewater collection system. The site is adjacent to the District's existing boundaries. Current status is <u>pre-application</u>. Preliminary coordination among the CSD, the County, and property owner representatives is underway.

3. City of Salinas: Target Area "K" (Ferrasci Ranch) sphere amendment and annexation of approximately 100 acres at the northeast corner of Harrison Road and Russell Road. Status is <u>pre-application</u>.

The site, just north of Salinas and designated as Target Area K in the City's recently approved Economic Development General Plan Element, is planned for industrial and commercial development. In 2019, the County and City approved a site-specific amendment of the Greater Salinas Area Memorandum of Understanding to facilitate the City's annexation and development of this site. Informal pre-application discussions have been underway with County staff, City staff and property owners since January 2020, most recently in February 2022.

- 4. City of Marina:
 - a. Former Fort Ord Landfill and Landfill Border Parcels Annexation of an approximately 341acre former Army landfill and landfill border parcels area (south of Imjin Parkway, north of Intergarrison Road, east of 8th Street, and west of Abrams Drive), and detachment of this area from Monterey County Regional Fire District. Current status is <u>pre-application</u>. In 2020, Monterey County and City of Marina entered into an agreement to convey its landfill border parcels (approximately 177 acres) to the City of Marina and designate the City of Marina as recipient of the former landfill parcels (approximately 164 acres) from the U.S. Army. The City

of Marina and County of Monterey also agreed to seek prompt annexation of these properties to the City of Marina. The area is currently uninhabited and includes a five-acre commercial area known as the Ord Market. The area is within the City of Marina's existing sphere of influence.

b. East Campus Housing Areas – Annexation of California State University Monterey Bay (CSUMB) East Campus housing areas (Schoonover and Frederick Park neighborhoods between Reservation Road and Imjin Road), and detachment of this area from Monterey County Regional Fire District. Current status is <u>pre-application</u>. Both housing areas are in Marina's sphere of influence and have a combined population of about 3,000.

Among other considerations, LAFCO's review will include each proposal's potential effect on fire and emergency medical service delivery models and related revenues to the affected agencies. Initial discussions with the parties occurred in 2019. There is currently no specific schedule for the City to submit an application or applications.

5. City of Greenfield – Annexation proposal with two separately owned parcels (vacant Thorp parcel and an existing elementary school site) on Apple Avenue west of the existing city limits. The original application is <u>incomplete</u>, and a revised project is in <u>pre-application</u> status.

In 2017, the City submitted an annexation application for a proposed residential project on the Thorp parcel, but that application remains incomplete. The City is now pursuing development of a community center – rather than housing – on the Thorp parcel. Staff met with the City in 2022 to discuss annexation of the proposed community center parcel and existing school parcel.

6. Technical Assistance to Local Agencies in Greenfield: LAFCO serves as an informal facilitator and information clearinghouse for small cities and special districts challenged by financial, governance and service delivery issues. Recent staff efforts have focused on special districts in Greenfield, Spreckels, Soledad and North Monterey County.

Greenfield Memorial District Board members, employees and community members have contacted LAFCO staff expressing concerns about the District's governance, transparency, accountability and operations. These concerns include challenges in retaining board members and obtaining a quorum of Board members to conduct District business, possible lapses in financial reporting, human resources issues, and substantial repair and maintenance issues. As a first step, LAFCO staff provided an educational Board orientation training to the Memorial District on April 26.

Based on the serious challenges the Greenfield Memorial District is experiencing, LAFCO staff is preparing an updated Municipal Service Review and Sphere of Influence (MSR/SOI) study for the District. To be completed in 2023, the study will explore the District's challenges, provide recommendations for immediate improvement, and identify potential options going forward. We will include a review of the City of Greenfield and the Greenfield Fire, Recreation and Cemetery Districts, consistent with timely, periodic review of these agencies. The study will provide a comprehensive approach to identify potential partnerships, explore opportunities for increased integration, and/or review other efficiencies among Greenfield-area local public agencies.

7. County Service Area (CSA) 25 – Quail Lodge Golf and Country Club: Potential expansion of the CSA's boundaries. Status is <u>pre-application</u>.

This CSA was formed in 1963 to provide street and sidewalk, storm drain, and road shoulder maintenance for the Valley Greens subdivision and golf course. The area consists of a golf course, 165 single-family residential lots, and 21 condominium lots, serving about 400 people. Services are provided by the County Public Works Department. Several CSA residents contacted the County and LAFCO to potentially add several adjacent parcels to the CSA. LAFCO staff participated in a CSA

advisory committee meeting in April 2021 to provide an overview of the annexation process. LAFCO and County met in August 2021 to coordinate on the project.

In addition, our staff met with the County and Carmel Area Wastewater District in March 2022 to discuss and coordinate sewer and road improvements in this area.

8. Drinking Water Project North of Moss Landing

LAFCO staff met with representatives from the Community Water Center (CWC), a non-profit for community-driven water solutions, in 2021. Due to water quality issues in the unincorporated County area north of Moss Landing, the CWC prepared a report to identify potential solutions to provide safe potable water to approximately 90 households in this area. CWC is working with PSMCSD, the closest public water provider in the area. LAFCO staff provided relevant information to CWC representatives regarding potential LAFCO actions that could facilitate the extension of PSMCSD's potable water services to this area. Current status is <u>pre-application</u>.

9. Salinas Valley Healthcare System (SVMHS) – Potential annexation in North Monterey County to align with boundaries of the newly formed Pajaro Valley Health Care District.

Part 3: Other LAFCO-Initiated Studies

In 2022, LAFCO completed a Municipal Service Review/Sphere of Influence study for the City of Soledad.

Currently, staff is preparing a Municipal Service Review/Sphere of Influence study for five Greenfield-area agencies to help address local challenges (see page 2 of this report). The agencies are the City of Greenfield, Greenfield Memorial District, Greenfield Fire District, Greenfield Cemetery District, and Greenfield Public Recreation District. The study will be completed in 2023.

In 2023, staff will begin a Municipal Service Review/Sphere of Influence study for the City of Gonzales to coincide with that City's anticipated annexation application (see page 2 of this report).

Also in 2023, we intend to begin a Municipal Service Review/Sphere of Influence study for the City of Marina. The study will focus on issues such as future growth and provision of services.

EXECUTIVE OFFICER'S REPORT:

CALAFCO Board of Directors

Following the January 17, 2023 vote on assignments by the Monterey County Board of Supervisors, Supervisor Chris Lopez will not be retaining his seat on LAFCO. In accordance with Article IV of the CALAFCO Bylaws, Supervisor Lopez has resigned from service as a Director on the Board of the California Association of Local Agency Formation Commissions. Per the CALAFCO Bylaws, a vacancy of a Board Director may be filled by the Board for the balance of the unexpired term and until a successor has been elected and qualified by the Board in accordance with Board-adopted election procedures. Please see Agenda Item nine for additional information.

Quarterly Report

The CALAFCO Quarterly Report is attached for information (Attachment 1). The report provides updates from the CALAFCO Board meeting in December 2022, including CALAFCO Board Committee appointments and the CALAFCO Executive Director's contract extension.

Legislative Committee

Commissioner Lopez raised concerns to the CALAFCO Board in 2022 against pursuing a legislative proposal to clarify LAFCO's oversight regarding out-of-agency service extensions. In July 2022, the CALAFCO Board voted in favor, 9-1, Lopez dissenting, to commit resources to this legislative proposal.

The issue that this legislative priority seeks to address – local agencies in some counties are determining by themselves to be exempt from LAFCO review of out-of-agency service extensions – is not an issue experienced in Monterey County. Monterey LAFCO already has necessary authority, our local agencies respect that authority, and we do not want to create an issue where there is no problem and that could be

harmful to our cooperative relationships. The issue has also generated informal opposition from the California Special Districts Association (CSDA).

To reinforce previous concerns on this issue, Executive Officer Kate McKenna sent a letter (Attachment 2) to the CALAFCO Legislative Committee in January 2023. The letter objects to pursuing the legislative proposal. Senior Analyst Jonathan Brinkmann spoke at the Committee's meeting on January 13. The Committee voted to form a sub-committee to develop compromise language intended to address the concerns of stakeholders. We will stay engaged with CALAFCO on this matter.

A Message from the

Executive Director

Whirlwind Journey

There is something about December that soothes my soul. Maybe it's the changing weather, the holiday sights and sounds, the children oozing with excitement, or maybe it is just knowing that the upcoming change of years allows a little downtime and an opportunity to reflect, rejuvenate, and regrow. That is particularly true this year as December also marks my tenth month as the CALAFCO Executive Director. It has been a bit of a whirlwind journey, but I have been SO glad to have you all by my side.

With the disruption of the pandemic, it's no wonder that the last two years have been challenging for CALAFCO – as with many nonprofits across the country. However, the experience caused us not only to re-examine how we conduct business but to streamline some areas. Following 20 years as a Contra Costa LAFCo Commissioner, six years as Martinez City Council member, and 20 years as Mayor of the City of Martinez, Rob Schroder is retiring. During his tenure, Rob served on various committees and regional government agencies and boards, including the Contra Costa Transportation Authority (CCTA) (22 years), Central Contra Costa Identification Bureau (19 years), Marin Clean Energy (MCE) (3 years), and was an active member of the Contra Costa Mayors Conference. The MSR process, although confusing when we first started the process many years ago, became a valuable tool in analyzing the efficient delivery of service and identifying deficiencies, areas, and entities that need to be improved or dissolved. Being a LAFCo commissioner made me a better Mayor with the knowledge of the annexation process and the efficient delivery of services."

Other matters on the Board's December 9th agenda included receipt of the Investment and Financial Reports for the First Quarter, adoption of the Board's meeting schedule for the next year, approval of an RFP for Accounting Services, and receipt of the Conflict of Interest forms, Legislative Committee report, and Conference Overview.

Speaking of the conference, we must express thanks and gratitude to Paul Novak (Los Angeles) and Carolyn Emery (Orange), for their extraordinary fundraising. Because of their efforts, the conference posted a small profit of approximately \$5,000 - despite the nearly \$32,000 in additional fees that we were obligated to pay due to the cancellation of the spring workshop. Hopefully, we can keep these efforts going next year!!

The last item of the meeting was a closed session evaluation of the Executive Director's (ED) performance. At it's conclusion, the Board announced that the term of the ED's employment contract was extended to June 30, 2026, that they had formally approved a 4.9% cost of living increase (the allocation for which had been approved in April with the adopted budget) and, due to security concerns at the current CALAFCO office, approved the ED working remotely from any location, subject to approval by the Executive Committee. Richmond Council member, and the past eight years as the City's Mayor, Tom Butt is retiring. Tom served on multiple boards and committees including MCE, CCTA, San Francisco Bay Conservation and Development Commission, West Contra Costa Transportation Advisory Committee, Association of Bay Area Governments, US Conference of Mayors, Climate Mayors, League of California Cities, and was an active member of the Contra Costa Mayors Conference. Commissioner Butt notes that these regional and statewide appointments have been critical in bringing many benefits to the community including hundreds of millions of dollars in grants, public works projects, legislation, and a seat at the larger table. During Tom's tenure, LAFCo processed 95 applications, including numerous boundary changes/ reorganizations, five dissolutions, and most recently, a large fire district reorganization and an out of agency service contract for fire services. During Commissioner Butt's tenure, LAFCo completed 1st and 2nd round MSRs/SOI updates covering all municipal services.

In 2019, both commissioners shared in receipt of CALAFCO's "Most Effective Commission" award. Contra Costa LAFCo Commissioners were recognized for their leadership, diligence, and endeavors to promote healthy and sustainable local agencies. Since 2010, Contra Costa LAFCo Commissioners assisted three special districts to improve their operations and transparency, encouraged several districts to revise its governance structure, reorganized one special district, and dissolved four special districts.

ALAMEDA CONDUCTS MEASURE D STUDY

Alameda LAFCO recently conducted a special study regarding ballot Measure D that was passed in November of 2000 and did the following:

- Amending the County's Urban Growth Boundary
- Increasing restrictions on building intensity, minimum parcel sizes and permitted uses in rural areas of the County
- Establishing that all County planning policies and zoning regulations must be consistent with provisions of Measure D, and
- Mandating that any changes to the land use designations, building intensity or minimum parcel sizes as established by Measure D be subject to a new vote of the County electorate

The study's purposes were to review how Measure D has affected agricultural and open space lands and the surrounding communities, and to consider how implementation of Measure D has or has not met its own LAFCO policies pertaining to agriculture and open space. The study found that since the measure's passing, the agricultural and equestrian communities of Alameda County argue that the strict square footage limitations hinders their business performance. Alameda LAFCO recommended proposed amendments to the County to allow equestrian centers, greenhouses and wineries more flexibility in their building plans.

This November, Alameda County voters approved the recommended amendments on Measure D, or the "Save Agriculture and Open Space Lands" initiative, that aimed at increasing profits for agriculture business while simultaneously preserving the county's open land.

that we've already begun fielding questions from potential bidders.

The second large administrative undertaking for 2023 will be the website. We have known since March of this year that the platform on which our website has been built is being retired. So far, our vendor has been able to keep the website functioning at an increasing cost. However, the underlying computer language that it uses will not be supported at all after November, 2023. Given that we have no choice but to rebuild the website, it presents the ideal opportunity to upgrade it to an Association Management System (AMS) which will provide more features to the membership, while reducing some of the repetitive administrative things that Jeni does behind the scenes. We are currently in the process of comparing costs and features between available AMS systems and hope to be able to bring something before the Board in the first part of 2023.

While that's a lot, we're also planning for the Fall Conference. Our October event was so successful that I have already begun hearing from sponsors who are interested in the Monterey conference.

Beyond that administrative matrix, we also foresee a busy year for the Legislative Committee who will be working through some of the backend things needed to get the GC 56133 proposal moving. Now that our new White Paper has been published ("Planning for a Sustainable and Predictable Future: Clarifying LAFCo Authority to Determine Government Code Section 56133(e) Exemption Eligibility"), we can begin the process of reaching out to stakeholders.

Lastly, I am pleased to report that at its December 9th meeting, the Board approved an extension to my employment contract through June 30, 2026. I am gratified beyond measure at the faith they, and you, have placed in me and I hope to continue to be worthy of it in the years to come.

Hopefully, you can tell that I am exhilarated by the opportunities and prospects before us. While the year has been a bumpy one, it has led to good friendships, great partnerships, and the start of some wonderful things. I call that a winning year!



Subject: Consideration of GC \$56133 legislative proposal (Re: January 13, 2023 Legislative Committee Agenda Item #7)

Dear Chair LaRoche and Committee Members,

This letter is in reference to the CALAFCO Legislative Committee's upcoming update and discussion of the California Government Code Section 56133 legislative proposal at its January 13, 2023 meeting under agenda item #7 and in reference to the CALAFCO Board's previous direction to survey Executive Officers to gauge support for this legislative proposal. Although the survey has not yet occurred, I am taking this opportunity to express opposition to the proposed legislative solution presented in the recent 2022 White Paper and to recommend that CALAFCO abandon this legislative proposal.

Monterey LAFCO Commissioner/CALAFCO Board Member Chris Lopez raised concerns and voted against the motion to pursue this effort at the July 22, 2022 CALAFCO Board meeting. I reiterate Monterey LAFCO's concerns, as follows:

- 1. Cities and districts in Monterey County are not self-exempting from LAFCO review of out-of-agency service extensions; this is not an issue for us.
- 2. This effort may call into question LAFCO's existing authority under Government Code Section 56133(e).
- 3. This effort may appear to cities and districts as LAFCOs seeking to add a new power or authority.
- 4. This effort may erode LAFCOs' relationships with cities and districts.
- 5. This effort is divisive to the CALAFCO organization.

We understand that some LAFCOs are concerned with misinterpretations of 56133(e). Specifically, cities and districts in some counties have determined by themselves, instead of through LAFCO, to be exempt from LAFCO review of out-of-agency service extensions. The 2022 White Paper: *Clarifying LAFCo Authority under Government Code Section 56133(e)* proposes amending California Government Code Section 56133 to clarify LAFCO's oversight role. Monterey LAFCO instead recommends that LAFCOs use appropriate local solutions to address the issue in cooperative dialogue with cities and districts. One potential local solution would be to amend a LAFCO's Local Policies and Procedures to clarify LAFCO's oversight role.

In conclusion, for the reasons expressed in this letter, I urge the Legislative Committee to end further efforts to advance the Government Code 56133 legislative proposal. No legislative clarification is necessary, the risks outweigh the potential gains, and alternative local approaches to address the issue are available to concerned LAFCOs.

SUMMARY OF RECOMMENDATION:

EXECUTIVE OFFICER'S REPORT:

Pursuant to Section 18 of the LAFCO bylaws, standing or ad hoc committees of the Commission may be established from time to time. At present, the Budget and Finance Committee is the only active committee of the Commission. The Budget and Finance Committee meets with the Executive Officer, staff, and financial consultants generally four times per year to examine LAFCO's finances and make recommendations to the full Commission on the utilization of funds available over the current and prospective fiscal years.

The Committee currently has a vacancy now that Supervisor Chris Lopez will not be retaining his seat on LAFCO after agency assignments by the Board of Supervisors on January 17, 2023. Special District Member Commissioner/Chair Leffel and City Member Commissioner Oglesby currently serve on the Committee. Staff recommends that the Commission fill the current Committee vacancy by appointing a third Commissioner.

EXECUTIVE OFFICER'S REPORT:

Staff informed CALAFCO on January 18, 2023 that Supervisor Chris Lopez has resigned as a CALAFCO Director due to a change of his assignments by the Monterey County Board of Supervisors. Subsequently, CALAFCO Executive Director Rene LaRoche sent an email to LAFCO Executive Officers comprising the 15-county Coastal Region advising them of the vacancy. Executive Director LaRoche's email also initiated the process of identifying County Members of LAFCOs within our region who may be interested in filling the unexpired Board term through October 2024.

CALAFCO policy 5.5.8 states that: "Vacancies on the Board of Directors may be filled by appointment by the Board for the balance of the unexpired term. Appointees must be from the same category as the vacancy, and should be from the same region."
