

## **Overall Response**

- Period of heavy rain from December 26, 2022, through January 16<sup>th</sup> 2023, which saturated the ground and brought rain, flooding, and wind.
- With countywide flooding, the county and several incorporated cities, and special districts proclaimed a local emergency.
- The Monterey County Department of Emergency Management activated its Emergency Operations Center. The City of Salinas joined our EOC. Other cities and county department activated their EOC's and Department Operation Centers.

# **Major Areas of Concern**

- All watersheds including Salinas, Carmel, Pajaro, Arroyo Seco, and Big Sur Rivers
- Risk of levee system failure
- Risk of localized flooding from rains
- Flooding along creeks and drainage courses
- Risk in burn scars due to extended length of rain
- Compromised public infrastructure and roadways.

# **Significant Events**

- The County of Monterey declared a local emergency on 12/27/22.
- The State of California has declared an Emergency for "2022-2023 Early Winter Storms" 1/4/23.
- California's Governor Newsom requested a Presidential Emergency Declaration on 1/8/23.
- Presidential Emergency Declaration EM-3594-CA supporting the response was granted 1/9/2023.
- Monterey, San Luis Obispo and Santa Barbara counties have been added to the major federal disaster declaration for California's severe storms and flooding on 1/19/23.

## **Initial Damage Assessment**

- County Wide Initial Damage Assessments are above \$120M
  - Including Initial Response and Emergency Repairs
  - Including Agriculture Industry.
  - Including Cities and Special Districts


## **Public Assistance**

- At present the declaration only includes Categories A & B and Individual Assistance
- Currently County, State, and Federal officials are conducting damage assessments to qualify the county for Permanent Work.
- There are many permanent work projects that are critical to public infrastructure for the other Categories Dam, Tide Gates, Parks, Sewage Treatment Ponds
- EMERGENCY WORK MUST BE COMPLETED WITHIN SIX MONTHS
- Category A: Debris removal
- Category B: Emergency protective measures
- PERMANENT WORK MUST BE COMPLETED WITHIN 18 MONTHS
- Category C: Roads and bridges
- Category D: Water control facilities
- Category E: Public buildings and equipment
- Category F: Public utilities
- Category G: Parks, recreational, and other facilities



### Road Closure & Info Page (5 Jan 23 @ 1710)






