The existing building to be demolished (Lyndsley Science Building) is a little smaller, but the project will not increase the number of students or faculty at the campus. Grading will be a little over 5000 cubic yards. The new building will be in essentially the same area on APN 008-022-033. Other site work will occur on APN 008-022-023 (e.g., utilities, grading, access paths, landscaping). The site plan Cover Sheet CS 0.00 has a good summary of the project details. Twenty protected trees (oaks and pines) are proposed for removal (Sheet L0.00).
