- There will be temporary structures.
 - Event organizers have applied for their permits.
 - Submitted permits for the tent and temporary structure.

- Dona Luna (Monterey County Parks) provided the following comments:
 - Requested clarification regarding parking alongside toro park.
 - Dona requested a copy of the encroachment permit application event organizers submitted.

- This is a fundraising event.

- o Will be utilizing San Lorenzo Park as one of their 7 campsites.
- Set up at the park will begin Sunday June 4, 2023.

- Riders will arrive on Monday June 5, 2023.
- Riders will be leaving the camp site Tuesday June 6, 2023.
- Expecting about 3,000 participants at the park.
 - 2,000 cyclists.
 - 650 volunteers.
 - A few hundred vendors.
- Are in the process of completing their applications for the temporary structures.
 - Waiting for the final calculations from tent vendors.
- Will have a vendor to provide generators.
 - Event organizers will apply for the necessary permits.
- There will special services onsite for participants such as:
 - Medical
 - Vendors
 - Catering
 - This will only be for the participants.
 - Sports Medicine
 - Massage services
- o Route marking arrows will be placed on June 4, 2023.
 - Cyclists will enter on Beach Street on June 5, 2023.
 - Will exist Monterey County on June 6, 2023.
 - Cyclists will obey all rules of the road.
