INSTRUCTIONS FOR COMPLETION OF STATEMENT

Section 17923 Business & Professions Code

17923 (a) Any person who is a general partner in a partnership that is or has been regularly transacting business in a fictitious business may, upon withdrawing as a general partner, file a statement of withdrawal from partnership operating under fictitious business name. The statement shall be executed by the person filing the statement in the same manner as a fictitious business name statement and shall be filed with the county clerk of the county where the partnership filed its fictitious business name statement.

17923 (b) The statement shall include:

- (1) The fictitious business name of the partnership.
- (2) The date on which the fictitious business name for the partnership was filed and the county where filed.
- (3) The street address of its principal place of business in this state or, if it has no place of business in this state, the street address of its principal place of business outside this state, if any.
- (4) The full name and business mailing addresses of the registrant or registrants withdrawing as a partner.

17923 (c) The withdrawal of a general partner does not cause a fictitious business name to expire if the withdrawing partner files a statement of withdrawal in accordance with subdivisions (a) and (b) and the requirement of subdivision (c) is satisfied.

NOTICE TO PERSON(S) - Section 17924 Business & Professions Code

The Statement of Withdrawal from Partnership operating under fictitious business name must be published in a newspaper once a week for four successive weeks and an affidavit of publication filed with the county clerk within 45 days after publication has been accomplished. The statement should be published in a newspaper of general circulation in the county where the principal place of business is located. The statement should be published in such county in a newspaper that circulates in the area where the business is conducted (Business & Professions Code 17917).

Any person who executes, files, or publishes any fictitious business name statement, knowing that such statement is false, in whole or in part, is guilty of a misdemeanor and upon conviction thereof shall be punished by a fine not to exceed one thousand dollars (\$1000) (Business & Professions Code 17930)
