  - Lake Bed, Marketplace will have build outs
  - o Paddock will be utilized similarly to reunion events at the venue
  - Track will not be used for professional-level racing
  - o In 2018, there were 80,000 attendees over 4 days; current Ticket Sales already at 60%
  - Traffic Plan coordinated with CHP
  - Event will most likely need off-site parking and shuttle service
  - Most Hotels in 5<sup>th</sup> District are sold out for this event
