## Public Comments for the October 23, 2023 LAFCO Meeting

Hello members of LAFCO, my name is Juan Navarro, and I own property at 40930 12th st and 40940 12th, just outside the city of Greenfield. Our well/water system has been dealing with Nitrate levels above the Maximum contaminant level at 16 mg/L for both properties and 0.02 ug/L of 1,2,3 TCP at the first property and 0.0038 ug/l of 1,2,3 TCP at the second property. We are currently working with our neighbors on finding a long-term solution to this problem.

I am commenting today because the MSR should not be approved at this point because my two properties and several of my fellow neighbors along areas such as Walnut Avenue are not included in the Sphere of Influence. The current MSR shows our area as uninhabited, however I am here to say we do exist and request that you include us in a revised draft.
