Request: Approve and recommend the Board of Supervisors approve a recurring NGEN Capital Fee of \$850,981 starting FY2024-25, which will be used to fund the NGEN operating reserves and asset replacement reserves, for future capital projects.

Summary/Discussion:

Neighboring radio agencies such as EBRCSA and SVRIA all have operating reserves and asset replacement reserves built into their annual fiscal plan. EBRCSA dedicates about 50% of their annual budget to fund their capital account and reserves. SVRIA sets aside 10% of their overall budget to fund the reserves and will likely increase to 50% in the coming years.

NGEN system was introduced about ten years ago and is aged. Some parts of the system already reached end of life and end of support and must be upgraded or replaced. In addition, NGEN system has coverage issues in certain areas that must be addressed. Operating reserves and asset replacement reserves must be set up to sustain the system so that first responders do not suffer from unplanned systems outages or poor radio coverage. County staff has identified a list of major capital projects over the next ten years in Exhibit A. According to the NGEN Services and Governance Agreement, regular system upgrades shall be funded as established by the Executive board and billed to each agency in the Capital Fee, or as a special assessment, as determined by the Executive Board and incorporated into the Emergency Communications Budget as approved by the Board of Supervisors.

NGEN maintains one Capital Fund (Fund 405) as part of its operational and long-term fiscal plan. However, there has been no recurring collection into the Capital Fund since the inception of the NGEN project more than ten years ago. A debt service collection to pay off the loan to fund the buildout of the system has been charged annually with the final debt service collection ending in FY2023-24.

County staff recommends that starting FY2024-25, a recurring NGEN Capital fee of \$850,981 be collected, which will be used to fund the NGEN operating reserves and asset replacement reserves, for future capital projects. Cost allocation (Exhibit B) to member agencies will follow the NGEN Capital Fee cost-sharing formula in the NGEN Services and Governance Agreement, which gives Fire Agencies a 75% weight on true-up device count. Cost allocations by department are summarized in Exhibit C and D.

Based on the last year's NGEN radio true-up of 2,655 and FY 23-24 NGEN Operation and Maintenance budgeted cost of \$1,226,271, per radio cost is about \$38.48 per month. With the proposed Capital fee setup, per radio cost is about \$65.20 per month.

This action item was unanimously approved and supported by the NGEN Operations Board unanimously on Oct. 19, 2023 (see attachment 6). NGEN capital project will be subject to NGEN Board approval yearly.

Staff Recommendation:

County staff recommends that starting FY2024-25, a NGEN Capital Fee of \$850,981 be collected with the plan to continue this fee annually. Cost allocation to member agencies will follow the NGEN Capital Fee cost-sharing formula in the NGEN Services Agreement. NGEN capital project will be subject to NGEN Board approval yearly.

Fiscal Impact: Funding the NGEN Capital Fund (Fund 405) will benefit NGEN fiscal health and make the system more sustainable.

Effect(s) of Failure to Approve Request and/or caveats: NGEN system is aged, and some parts of the system already reached end of life and end of support and need to be upgraded or replaced. In addition, NGEN system has coverage issues in certain areas that must be addressed. Capital fund must be set up to sustain the system so that first responders do not suffer from unplanned systems outages or poor radio coverage.
