#### LUP Background

- Big Sur Coast Land Use Plan (BSLUP) adopted by the Monterey County Board of Supervisors November 5, 1985
- BSLUP certified by the California Coastal Commission April 10, 1986
- Foundation of the BSLUP protection of the unspoiled natural scenic environment of the Big Sur Coastal Planning Area

## LUP Background

- Application of BSLUP to all public and private agencies
- Shared commitments to limit development and protect the natural environment
- Ensured access for the traveling public to the Big Sur Coastal Planning Area



## LUP Update Background

- Updates to the BSLUP began in 2013 when the Big Sur and South Coast LUACs began a series of public workshops
- Two public workshops were held in 2021, where the Planning Commission appointed an Ad Hoc Committee
- Ad Hoc Committee took the LUACs recommendation, and all public input received when preparing the revised draft BSLUP update

#### **Framework for Revisions**

- Existing BSLUP is the "gold standard" of Local Coastal Programs and balances competing interests relatively well
- Updates were made only where the Ad Hoc Committee believed changes were needed to reflect the current on-the-ground conditions
- <u>Forward looking</u> updates are intended to make the BSLUP forwardlooking to continue to protect the Big Sur Coastal Planning Area
