Request:

1. Recommend the ECD Executive Board approve the April 2023 NGEN Device True-Up (Exhibit A) to be used in the FY2023/24 NGEN O&M and Debt Service billings.

Summary/Discussion:

Next Generation (NGEN) Radio system costs, including Debt Service on the loan taken to build the system, and ongoing Operations & Maintenance (O&M) costs are charged to NGEN system users based on their proportion of total devices on the system. A "True-Up" of these devices is periodically conducted, at the recommendation of this Board and the direction of the ECD Executive Board, to be used for future cost sharing. The last time a True-Up was conducted was in December 2021 for use beginning in FY2022/23.

This True-Up included Digital and Analog radios as well as Broadband Push-To-Talk devices (ie. Be-On). It also weights fire only radios at 75%. This True-Up is consistent with the formula from the pending NGEN Services Agreement.

ECD & ITD Recommendation:

This board recommend that the ECD Executive Board approve the April 2023 True-Up for use in FY2023/24 NGEN billing.

Effect if not approved:

ECD will bill FY2023/24 costs using the existing February 2022/23 True-Up and if the NGEN services agreement is signed, will weight fire radios at 75%. If the NGEN Services Agreement is not signed, no weighting will be used.


