### Rural Community Center Zoning District

- Original 1986 BSLUP envisioned adoption of Rural Community Center Zoning District in areas with the Rural Community Center Land Use Designation.
  - Big Sur Valley
  - Lucia
  - Pacific Valley
  - Gorda

- Existing areas designated with the Rural Community Center Land Use Category have varying zoning.
- Rural Community Center Zoning District would apply to all areas that have the Rural Community Center land use designation.

Encourage affordable and employee housing






## Possible Expansion of Rural Community Centers in Big Sur Coastal Planning Area
