Public Administrator Services

The County of Monterey Public Administrator's Office must take possession of property of a person who dies in Monterey County if all the following are true:



Valuable property is at risk of being lost or stolen.

There are no persons, such as immediate or extended family of the deceased person, who are willing and able to serve as executor or administrator of the estate.

In limited circumstances, the Court can order the Public Administrator to act and serve as a personal representative, as a last resort, if the currently appointed personal representative is failing to carry out their fiduciary duties to the estate.



Public Conservator Services

LPS Conservatorship:

(Lanterman-Petris-Short) The LPS Conservator arranges for appropriate placement and mental health treatment/services for Monterey County residents deemed by a Court to be "gravely disabled." "Gravely disabled" means that the person has been diagnosed with:

A serious mental health disorder (such as schizophrenia); and/or

A severe substance use disorder and due to this diagnosed condition, they are unable to provide for:

- Basic Food;
- Basic Clothing;
- 📸 Basic Shelter;
- 😰 Personal safety; or
- 👻 Necessary medical care

Probate Conservatorship:

The Probate Conservator provides for frail, elderly, dependent and cognitively impaired adults who are:

- 🗐 Unable to manage personal affairs
- Unable to manage finances
- 🐏 Victims of financial abuse
- 📕 At risk of exploitation
- 📓 Unable to resist undue influence

Representative Payee Services

The Public Guardian can act as a Representative Payee, including applying to, and managing Social Security benefits for qualified Monterey County residents who are incapable of managing their:

- Social Security Income (SSA)
 - Social Security Disability Insurance (SSDI)
- 🧐 Supplemental Security Income (SSI)

Legal Criteria

Conservatorship of the Person:

 Inability to properly provide for physical needs for personal health, food, clothing, and shelter.

Conservatorship of the Estate:

• Substantially unable to manage financial resources or resist fraud or undue influence.
