## Frequently Asked Questions

### Who can get help at Holding on to Hope?

- Holding on to Hope helps survivors of domestic violence, child abuse, elder abuse, sexual assault, and human trafficking.

### Do I need an appointment?

- You do not need an appointment. Walk-Ins are always welcomed.

### How much are services?

- Many services provided are free. Some fees apply.

### What should I bring?

- You should bring legal documents including: existing restraining orders, child custody and visitation orders, and police reports or report numbers.

### Can I bring my children?

- Yes. We recommend that if you can, please bring another adult to watch your children while you receive services.

### Is transportation available?

- Yes, depending on availability. We can provide transportation for some appointments and court hearings.

### Do I need an interpreter?

- Many Holding on to Hope staff members are bilingual, speaking English and Spanish. We are also able to accommodate other languages.
