- The area between 7902 California Highway 1, Moss Landing (formerly The Whole Enchilada) and the start of the event venue will have barriers on both sides of the street with "No Parking, Tow Away" signs.
 - This will also be done from the corner of Moss Landing Road and Sandholdt Road to Sandholdt Bridge.
