2. Educational

- 1. Presentation from Derrick Elder: PowerPoint on the services of the City of Seaside-Family and Community Support Program. The program offers case management, referrals to partnering agencies for mental health, housing and family conflict, and mobile crisis. They receive calls through 911 and also to their main line. The program is free to the community. They do outreach and table at local community events.
- 2. Presentation on DV and SART: Faye explained the process for the Domestic Violence Forensic exams and the Sexual Assault Response Team (SART). A pilot program was conducted in Monterey County with Salinas Police Department, YWCA and SART team to conduct Domestic Violence Forensic Exams. These exams allow for more thorough information

about the incident to be collected and more thorough photos of the victim to be taken. It also allows an opportunity for the nurse practitioner to educate the victim on the potential risks.
