Rural Community Center Zoning District

- Original 1986 BSLUP envisioned adoption of Rural Community Center Zoning District in areas with the Rural Community Center Land Use Designation.
 - Big Sur Valley
 - Lucia
 - Pacific Valley
 - Gorda
- Existing areas designated with the Rural Community Center Land Use Category have varying Zoning District categories.
- Rural Community Center Zoning District would apply to all areas with the Rural Community Center land use designation.



Rural Community Center Zoning District – Questions, Comments, Input


- Provides Zoning District to encourage uses for the visiting public and residents;
- Reducing impacts to Highway 1;
- Encourage affordable and employee housing; and
- Exhibit C crosswalks with existing Title 20 Zoning District uses are from Coastal General Commercial, Moss Landing Commercial, and Visitor Serving Commercial.

BSLUP Land Use Designation and Zoning Maps

- Publication of a Geographic Information System (GIS) mapping application on the BSLUP Update webpage.
- Mapping application available for public to review at any time.

BSLUP – Coastal Implementation Plan (CIP) and 1982 General Plan (1982 GP)

- The BSLUP currently relies on the 1982 GP.
- Updating the CIP was not a part of the original BSLUP Update process.



BSLUP – CIP and 1982 GP – Questions, Comments, Input

 The Ad Hoc Committee and staff are seeking direction from the Planning Commission that staff research the additional time required to update the BSLUP to include all required General Plan Elements. Staff would also research the additional time required to update the CIP as part of the BSLUP Update process.
