Candidates seeking information about city offices and for city measures, please contact the appropriate City Clerk for specific requirements and deadlines.

Declarations of candidacy and other required nomination documents for eligible candidates desiring to run for an elective office may be obtained and filed at the office of the Registrar of Voters located at 1441 Schilling Place – North Building, Salinas, CA, on or after July 15, 2024 and must be filed at the same location not later than 5 p.m. on August 9, 2024. If an eligible incumbent does not file a declaration of candidacy by 5 p.m. on August 9, 2024, any eligible person other than the incumbent shall have until 5 p.m. on August 14, 2024 to file a declaration of candidacy for the elective office. Interested candidates may also call (831) 796-1499 for more information.

NOTICE IS HEREBY GIVEN that all active voters will receive a ballot by mail beginning no later than October 7, 2024. The last day to request a ballot by mail is October 29, 2024. Voters wishing to vote at their assigned polling place, must surrender their mailed ballot. Any voter unable to surrender will be assisted with a provisional ballot.

NOTICE IS ALSO GIVEN that the last day to submit arguments for or against any measures wholly situated within Monterey County submitted to the Monterey County Elections Department is by 5 p.m. on August 15, 2024. Arguments are limited to 300 words and may be signed by up to five persons.

NOTICE IS FURTHER GIVEN that the last day to submit rebuttal arguments in response to arguments for or against any measure submitted to the Monterey County Elections Department is by 5 p.m. on August 22, 2024. Rebuttal arguments are limited to 250 words.

NOTICE IS FURTHER GIVEN that measures from jurisdictions whose boundaries include multiple counties may have different deadlines that will be established by the lead county.
