As a property owner, tenant or person with vested interest in the project vicinity, please be advised that the County of Monterey, Solid Waste Local Enforcement Agency (LEA) has accepted an application to modify an existing Solid Waste Facility Permit (SWFP) from Converted Organics, LLC for the facility located at 31677 Johnson Canyon Road, Gonzales, CA 93926. The LEA is certified by CalRecycle to enforce state laws and regulations at solid waste sites within the County of Monterey, including all disposal facilities.

Purpose of the Public Notice

The LEA shall provide public notice upon accepting an application to modify an existing SWFP as complete and correct, §21650, Title 27. Public notification will be provided in accordance with §21660.3, Title 27, and will be made within 60 days of receipt of the application.

Description of Project

On June 18, 2024, the LEA received a permit application from Converted Organics, LLC to modify the existing SWFP for Converted Organics, LLC located at 31677 Johnson Canyon Road, Gonzales, CA 93926. Converted Organics, LLC is modifying their current compost permit to an in-vessel digestion permit.

Findings

The LEA has determined that:

- The application is complete and correct and meets the requirements of the California Code of Regulations, Title 27, Section 21570, and is approved.
- The facility's permit modification is to change their compost permit to an in-vessel digestion permit, as directed by their most recent 5 Year Permit Review conducted November 2020 and § 17896.3, Title 14.
- There are no proposed changes to the facility's operations, including tonnage, traffic, acreage, hours of operation.
