Rebuttal To Argument In Favor of Measure C

VOTE NO ON MEASURE C! VOTE NO on \$19 MILLION in new bonds. Everyone agrees that education is important. But bonds lead to generational indebtedness. Residents already pay a lot in income, property, sales, and gas taxes (plus inflation)! These bonds are a burden to homeowners, renters, businesses and customers alike!

- Property owners would pay higher property taxes. Renters would suffer rent increases as landlords pass on the cost of higher taxes.
 Customers would pay higher prices as businesses pass on the cost of higher taxes.NO ON MEASURE C!
- Proponents say there would be transparency and citizen oversight requirements. However, the 2022 Measure K West Hills Bond also passed with citizen oversight requirements. It mandated a sevenperson oversight committee. Yet, it has four vacancies. Most of the active members on that oversight committee are Community At-Large Members appointed by the Board of Trustees. This raises concerns about how much actual oversight there would be if Measure C passes.
 NO ON MEASURE C!
- The **true cost** of the bonds would be an estimated **\$32,000,000** (with interest), not \$19 million. Families benefit from keeping more of their hard-earned dollars in their pockets for groceries, gas, rent, and necessities. While proponents of the measure are cheering that it would increase property values, renters already facing higher rents would also find it more cost prohibitive to buy a home. Everyone agrees that education is important. But robbing Peter to pay Paul hurts Peter.
