Rebuttal To Argument In Favor of Measure CC

Vote No on Measure CC: Keep Our Community Safe and Support Our Nonprofits!

We understand the concerns raised by proponents of Measure CC, but the real problem lies with illegal fireworks, not State Fire Marshal-Approved, Safe and Sane Fireworks. Illegal fireworks are already banned!

At the August 4, 2022, City Council meeting, the City Manager and the Seaside Police Chief clearly stated that illegal fireworks were the issue and that banning state-approved fireworks could actually increase the amount and use of illegal fireworks in Seaside. Their expertise and experience should not be ignored!

Measure CC will have unintended negative consequences for our community:

- Increased Use of Illegal Fireworks: By banning Safe and Sane Fireworks, we risk driving people to use illegal, more dangerous fireworks. Illegal fireworks explode and fly, posing serious safety risks. Let's focus on the real issue and prevent this escalation. Vote No!
- Loss of Critical Funding for Nonprofits: Seaside nonprofits raise nearly \$300,000 annually through the sale of Safe and Sane Fireworks. These funds are vital for supporting essential community programs, including mental health services, educational support, and youth sports. Losing this revenue would jeopardize these important programs. Vote No!
