ILLEGAL DUMPING FINES

>>> WHAT'S CHANGING?

On February 27, 2024, the Board of Supervisors approved the proposal to amend Monterey County Code to increase fines for illegal dumping and littering. The new fines are as follows: \$2,500 for the first violation, \$5,000 for the second violation within 12 months, and \$10,000 for the third violation within 12 months.

This follows a similar 2023 ordinance by San Benito County in an effort to combat illegal dumping and littering offenses in the surrounding area.

>>> WHY IS THIS HAPPENING?

Illegal dumping and littering in Monterey County have had significant negative impacts on its citizens and its environment. Over the past five years, the County has spent over \$1.7 million cleaning up illegally dumped material. Despite this and clean up efforts by some residents, unlawful dumping and littering persists.





CAMERA SURVEILLANCE PROGRAM

>>> SUMMARY

- Environmental Health will purchase six cameras and support equipment from a company called Reconyx.
- · Public Works will assist with installation.
- Cameras will be located in select "hot spot" areas and installed within the right of way.
- Environmental Health will follow-up on illegal dumping and maintain chain of custody of video evidence.

>>> RECONYX CAMERAS

- General surveillance for law enforcement
- · Compact and mobile
- License plate capture capable
- Cellular service delivers images to cloud
- Regulatory agencies, municipalities, parks, DA offices have had good user experiences
- Affordable

BACKGROUND

- IDLATF mission is to stop illegal dumping in Monterey County through the 3E's-Education, Eradication, Enforcement.
- The use of cameras with enforcement is the leading edge of illegal dumping efforts in other county jurisdictions.

>>> OPERATIONS & ENFORCEMENT

- Public Works will install cameras within right-of-way at selected sites (known "hot spots") with cellular service.
- Environmental Health will follow-up on observed violations by:
 - Reviewing video evidence for people, vehicles, and license plate numbers.
 - Visiting the site if necessary
 - Coordinating with law enforcement to identify responsible parties
 - Report dumping to Public Works for clean-up
- Enforcement may include cost recovery, adminstration fees, or fines or referral to the District Attorney's office
