LAFCO Budget & Finance Committee Meeting Agenda Item No. 3

After finalizing the agenda packet for the November 14, 2024 LAFCO Budget & Finance Committee meeting, LAFCO's accounting firm (CliftonLarsonAllen, LLP) prepared and transmitted the October 31, 2024 Draft Balance Sheet and Income Statement (Attachments 3.2 and 3.3 to Item 3). Staff revised the November 14, 2024 Budget & Finance Committee Agenda for Item 3 to include these additional monthly financial statements for October, which are in addition to the September 30, 2024 quarter one financial statements.
