- Encroachment permits for parade traffic control are pending submittal.
- Emergency Medical Plan is approved.
- Pending contact with Sheriff's Office and Fire Department for participation in the parade and crowd control.
- Local businesses will allow attendees to utilize their restrooms without purchase or charge.
 - Use of facilities in business with age restrictions are limited to attendees old enough to patronize the business.

(Example: Only attendees 21 or older can use facilities in wine tasting rooms)

- Health Department permit for food service was pending payment, but was paid today.
- No food service proposed by the organizers, but sometimes the girl scouts sell hot chocolate.
- Generators are only used for the bounce house and this has recently been clarified with Housing and Community Development.
- Emergency Medical Plan has been approved.
- The community center will be blocked off from incoming and outgoing traffic during the event. Cones, tape and manned stations will be used to keep vehicles out.

Regulatory agencies' comments pertaining to this event:

- Liz Gonzales expressed appreciation event coordinators' cooperation with the county.
- Kayla Braasch confirmed that no construction permits are needed for the landing zone and parade.
- Kayla Braasch asked if there is any signage on site or on the road leading up to the Community Center indicating that the area is closed off. If so, asks if this has been incorporated into the traffic control plan submitted by Danielle Carlson.
 - Daniel Loberg state if what is proposed is on Danielle Carlson's traffic control plan, but states that signage regarding the closure is not posted along the roads. Only the entries are coned and taped off.

- Parking will be on-site.
- No complaints from neighbors from previous events in this series.

Regulatory agencies' comments pertaining to this event:

- Commander Joseph Bañuelos (Monterey County Sheriff's Office) wanted to confirm number of attendees and whether alcohol will be sold. Commander Bañuelos expressed concern regarding "bleed over" such as DUIs after these events end.
 - Kayla Braasch confirms that the Special Event Questionnaire confirmed that alcohol will be sold.
 - Kayla Braasch also confirmed that the Special Event Questionnaire was routed to the Sheriff's Office.
- Commander Andres Rosas states that the event organizer has not reached out with the Sheriff's
 event regarding supplemental law enforcement because nothing compels them to. High potential for
 fights and DUIs and law enforcement involvement will be high.
 - Liz Gonzales states there is a Use Permit pending approval with Housing and Community Development. She will route Commander Rosas's information to the Assigned Planner to ensure going forward all Special Events on this property will require supplemental law enforcement.
 - Original ratio was one to two deputies for every 1,000 attendees for special events.
 - o Kayla Braasch has asked if the ABC license for this event was received.
 - Commander Rosas confirmed that the ABC Permit and Dance permit were approved.
- America Leon (Health Department) states that they have received an application that lists two food vendors.
- Scott Anderson (Fire) points out that events with over 500 attendees will require licensed "crowd managers" and he believes that could apply to the Sheriff's Office
 - Commander Rosas will reach out after the meeting.
- Commander Andres Rosas confirmed that the Alcoholic Beverage Control permit and dance permit are approved for this event.
