Significant Areas Agreed Upon in March 16 Negotiation Session

Definition of covered work

- Exclusion/Inclusion of off-site manufacturing work
- > Agency obligations re: prevailing wage requirements
- Composition of labor/management committee



Current Status of Remaining Significant Areas Requiring Resolution

1. Availability of services with signatory trade crafts within County

Agency has proposed compromise language.

2. Exclusion of Required Environmental Mitigation Requested by Agency since such requirements are unknown as to scope, duration and location.



Current Status of Remaining Significant Areas Requiring Resolution (cont'd)

3. Effectiveness of PLA

Agency proposes language contained in Board Order WRAG 16-007 (regarding a favorable vote on AB 1585 accompanied by adequate funding for a design-build project) and requirement for a favorable 218 vote.

4. Composition of Arbitration Panel

Agency proposes a joint Building Trades/Contractor selection process.



Current Status of Remaining Significant Areas Requiring Resolution (cont'd)

5. Payment into Building Trades Benefit Plans for Non-Referral Employees

Agency proposes to exclude such payments to avoid double payment of benefits.

6. FERC-related Requirements for Background Checks for Personnel Working at Dam Sites
Agency requires inclusion in PLA.

Alternatives

Design-Build pursuant to AB 155

- Follows Public Contract Code and SB 785 procurement process requiring pre-qualification of bidders.
- CEQA approval required before solicitation of DB contractor.
- Requires completion of preliminary engineering and environmental work by the Agency prior to solicitation.



Alternatives

- P3 (Public Private Partnership) Design- Build-Finance pursuant to California Code 5956
 - Authorized by CA Government Code Section 5956 California Infrastructure Investment Act
 - Exempt from CA Public Contract Code procurement process
 - P3 concessionaire provides project development financing
 - CEQA approval not required before solicitation.
 - P3 concessionaire provides Guaranteed Maximum Price
 - State funding not allowed
