Germán Criollo, Associate Hydrologist, reported on this item. The end of flow in the Salinas River was not located but is estimated to be between river mile 70 and 74. To date this season, San Antonio has received a net increase of approximately 1,000 acre feet of

storage (an increase of approximately one foot in elevation). Nacimiento has received a net increase of 21,600 acre feet of storage (an increase of approximately 10 feet in elevation).

Nacimiento Reservoir elevation is 725.90 feet and 83,600 acre-feet of storage, 22% of capacity, and current release is 60 cfs.

San Antonio Reservoir elevation is 647.45 feet and 11,268 acre-feet of storage, 3% of capacity, and current release is 3 cfs.

SUMMARY:

The Board of Directors receives monthly updates on the status of Agency reservoirs.

DISCUSSION/ANALYSIS:

RESERVOIR ELEVATION / STORAGE: As of February 23, 2016, San Antonio Reservoir is at an elevation of approximately 649 feet mean sea level (msl), 12,029 acre-feet of storage. Nacimiento Reservoir is at elevation 726.95 feet msl, 84,680 acre-feet of storage. San Antonio Reservoir is currently at 4% of storage capacity and Nacimiento Reservoir is at 22% of capacity.

From the Seasonal low in early January, San Antonio Reservoir has received a net increase of approximately 1,800 acre-feet of storage while Nacimiento Reservoir has received a net increase of approximately 22,700 acre-feet of storage.

RESERVOIR RELEASES: Minimum fisheries releases continue from both reservoirs.

Releases as of February 23, 2016:

•	San Antonio Reservoir:	3 cfs
•	Nacimiento Reservoir:	60 cfs


Total releases from both reservoirs to the Salinas River are approximately 63 cfs. The following "provisional" flows have been recorded by the USGS:
