3. **APPROVE THE MINUTES OF THE RESERVOIR OPERATIONS COMMITTEE MEETING HELD ON DECEMBER 3, 2015**

**ACTION:** On motion and second of Committee members Baillie and Pozzi, the Committee approved the minutes.

4. **REVIEW THE STATUS OF BOTH RESERVOIRS; REVIEW RELEASES AND RELEASE SCHEDULE**

Jason Demers, Hydrologist, reported on this item. There is a flow of 76 cfs in the Salinas River at the Bradley gage. End of flow in the Salinas River is estimated to be between river miles 69 and 74. Nacimiento Reservoir received 0.6 feet (or 1600 acre-feet) of inflow from the recent rains. No inflow has been received for San Antonio except from the direct rainfall. Salinas has received about 1.50 inches of rain so far this month. South Salinas has

received 8 inches this season. The mountains have received 4-6 inches in the past seven days. At the dams there's been over 1 inch, and about 2 inches in the upper part of the valleys above the reservoirs.

Nacimiento Reservoir elevation is 717.40 feet and 63,650 acre-feet of storage, 17% of capacity, and current release is 60 cfs.

San Antonio Reservoir elevation is 645.50 feet and 10,254 acre-feet of storage, 3% of capacity, and current release is 3 cfs.

**5. RECEIVE REPORT ON THE STATUS OF THE OPERATIONS POLICY MANUAL FOR SAN ANTONIO AND NACIMIENTO RESERVOIRS**

Brent Buche, Deputy General Manager, and Germán Criollo, Associate Hydrologist, reported on this item. An update on the December 16, 2015 Reservoir Operations Policy Subcommittee meeting was provided. The next meeting of the Subcommittee is scheduled for February 17, 2016. Due to questions about public attendance at the Subcommittee meetings, County Counsel has advised that Subcommittee meetings are not subject to Brown Act regulations and only Subcommittee members should attend. Updates will be provided at the Reservoir Operations Committee meetings. Keith Roberts, a South County grape grower, will be added to the Subcommittee.

**ACTION:** On motion and second of Committee members Baillie and Pozzi, the Committee approved the addition of Keith Roberts, representative for the South portion of Monterey County, to the Subcommittee and approved to keep it as a Subcommittee.

**SUMMARY:**

The Board of Directors receives monthly updates on the status of Agency reservoirs.

**DISCUSSION/ANALYSIS:**

**RESERVOIR ELEVATION / STORAGE:** As of January 27, 2016, San Antonio Reservoir is at an elevation of approximately 646.3 feet mean sea level (msl), 10,659 acre-feet of storage. Nacimiento Reservoir is at elevation 725.9 feet msl, 82,165 acre-feet of storage. San Antonio Reservoir is currently at 3% of storage capacity and Nacimiento Reservoir is at 22% of capacity.

From the Seasonal low in early January, San Antonio Reservoir has received a net increase of approximately 400 acre-feet of storage while Nacimiento Reservoir has received a net increase of approximately 20,000 acre-feet of storage.

**RESERVOIR RELEASES:** Minimum fisheries releases continue from both reservoirs.

Releases as of January 27, 2016:

- San Antonio Reservoir: 3 cfs
- Nacimiento Reservoir: 60 cfs

Total releases from both reservoirs to the Salinas River are approximately 63 cfs. The following “provisional” flows have been recorded by the USGS:

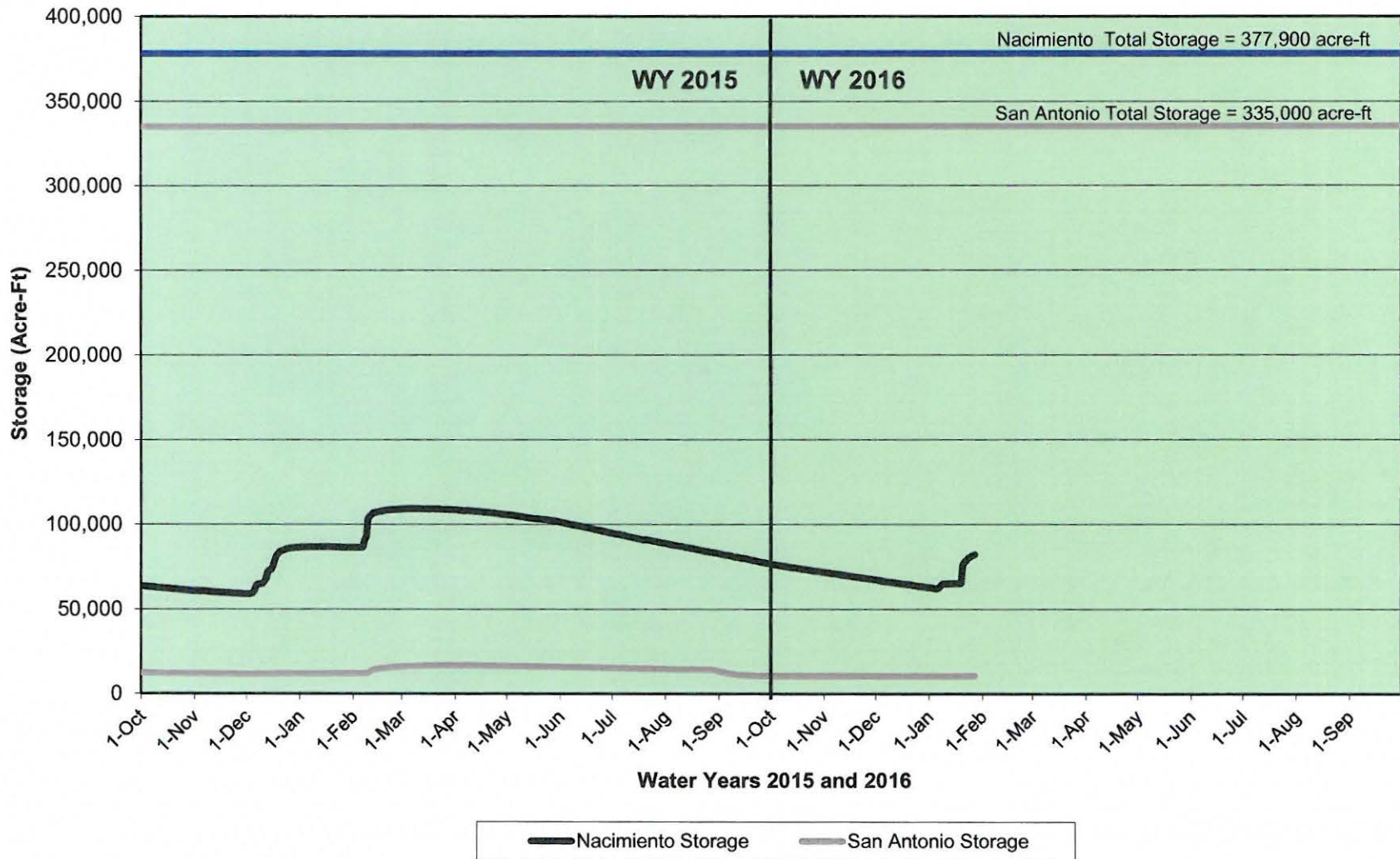
- Salinas River near Spreckels: 0 cfs
- Salinas River near Chualar: 0 cfs
- Salinas River near Soledad: 0 cfs
- Salinas River near Bradley: 70 cfs (steady)

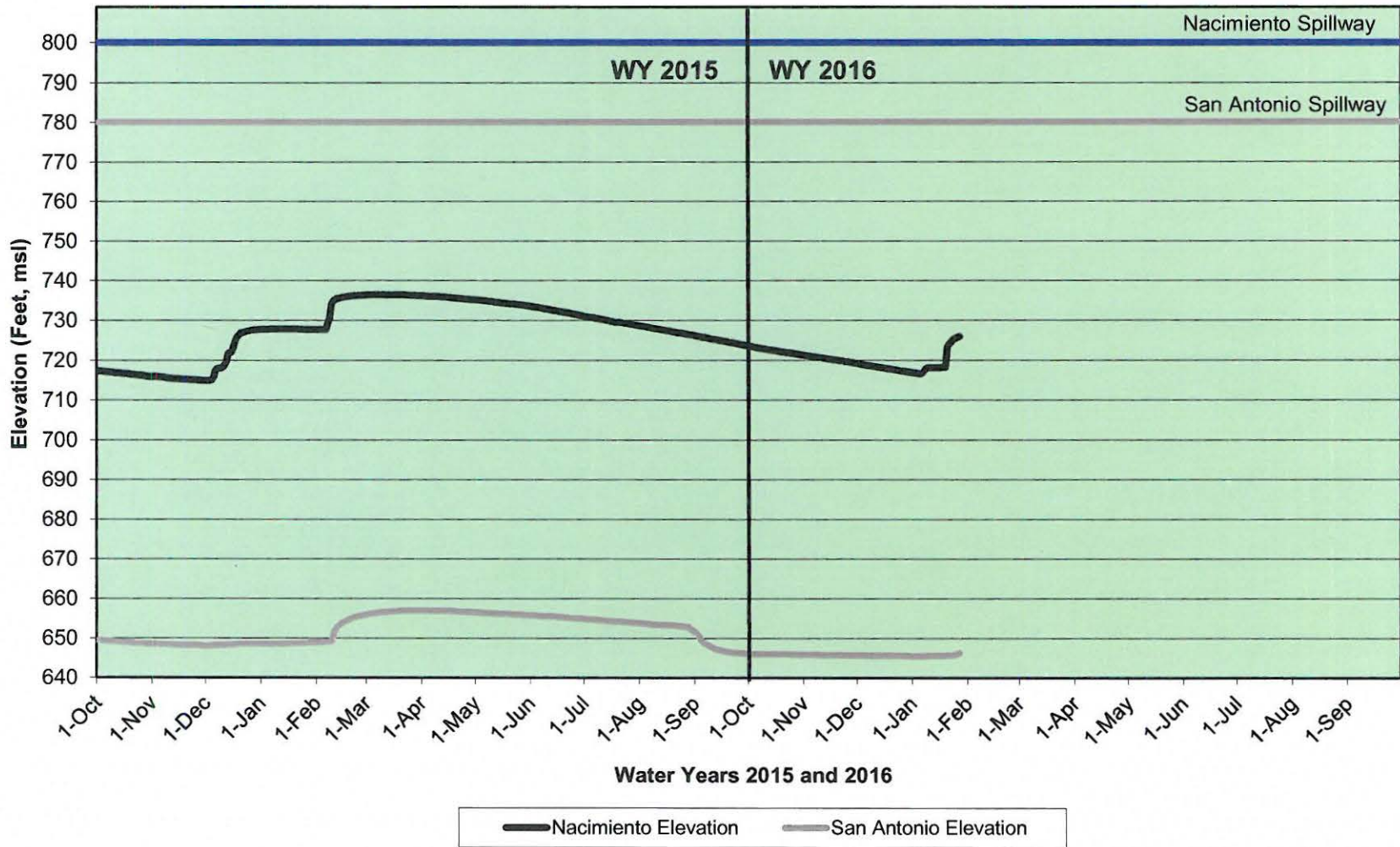


## Reservoir Storage

- NACIMIENTO "NWP Diversions" do not include lakeside water use which is estimated at approximately 1,750 acre feet per year.
