<u>Departmental Equal Opportunity Plan Presentation – Linda Tulett, Registrar of Voters</u>

Equal Opportunity Officer David Medrano introduced Linda Tulett, Registrar of Voters. The Elections Department currently has seven full-time employees (excludes the department head). In preparation for the elections held throughout the year, several temporary employees are hired for the Office. With respect to meeting the goals as outlined in The Monterey Plan for Equal Access to Employment and Contracting Opportunities (The Plan), in the category of Management II, all (1) are minorities. In the category of Management II, the department has exceeded the goal of 30.2%. All (1) are minorities in the Paraprofessionals-Technicians I category (exceeds goal); and in the Office/Clerical I category, 25 percent are minority (1 minority, 3 non-minorities, has not met the goal of 45.8%). No minorities are in the Professional – Administration category, of which one (1) employee is assigned (goal is 31.1%) Since the Elections department has few positions, there are not many promotional opportunities within the department. It is also difficult to obtain employees with elections experience. The department is committed to hiring employees with "cultural competence" and who can meet the needs of the community in which the department serves. After a brief questions and answers session, Registrar of Voters, Linda Tulett was thanked for her presentation.
