### **IV. NEW BUSINESS**

### A. Greg Smith, Monterey County Supervising Park Ranger

In celebration of Royal Oaks Park (Royal Oaks) 40th Anniversary, Mr. Smith spoke about the parks accessibility. Mr. Smith was involved in making Royal Oaks accessible. Over 10 years ago the Parks Department (Parks) began to upgrade the Hidden Oaks Group Area (Hidden Oaks) in Royal Oaks in order to be ADA compliant. Parks decided to take a hands on approach to designing Hidden Oaks. Parks invited an individual in a wheel chair to go through the area and provide feedback on what changes were necessary for her to feel comfortable. As a result of her suggestions the picnic and serving tables, barbecue pit, and play equipment were designed to allow wheelchair access. In addition to those accommodations, there is a

barbecue area designated for the disabled only. Chair Pinio informed the commission that there are 12 capital projects throughout the County Parks system that have been identified to get ADA upgrades in the next few years.

#### C. Equal Opportunity Officer Remarks

Equal Opportunity Officer David Medrano was not present so Equal Opportunity Analyst Sonjé Dayries reminded the commissioners of an Ethics training offered by the County on October 19th. Equal Opportunity Analyst Sonjé Dayries announced that it is National Deaf Awareness Week.

Outreach Committee Report – Commissioner Bogan showed the commissioners a framed letter of recognition to be presented to Hartnell College for its commitment to ensuring equal access.
