#### VIII. OLD BUSINESS

Smith suggested the Access/Outreach Committee talk to Social Services about our Commission. Com. Almanza reminded the group that Director Elliott Robinson, from Social Services, did speak to this group in 2003. Com. Hinds is the rep for the In-Home Support Services Meetings.

• Allen Bidwell, Deputy County Counsel, provided revised version of By-laws for review. Next step is to approve revised by-laws, action item for next meeting.

- **A.** Discussion regarding vacancies. Chair Flynn asked for count of those commissioners who will be seeking another term after their current terms expire in December 2004. Commissioners Foglia, Cook and Flynn will not be seeking another term, Commissioner R. Smith is undecided. Commissioners asked regarding terms and reappointment, these are 3-yr terms and commissioners can be reappointed. See By-laws. Com. Foglia stated her organization is under staffed and would probably have a problem appointing a new rep to this Commission, also her goal in joining was to focus on employment for the disabled and the group never quite got to that. Commissioners need to submit letter of resignation and organizations need to submit letter appointing new rep.
