## RECOMMENDATION:

Staff recommends that the Planning Commission conduct a public hearing to consider an amendment to the County's General Plan to update the Housing Element and adopt a resolution (Exhibit B) to recommend that the Board of Supervisors:

- Adopt the Negative Declaration for the County of Monterey 2015-2023 Housing Element (Exhibit C);
- 2) Adopt the County of Monterey 2015-2023 Housing Element (Exhibit B, Attachment 1) in substantially the same form as attached herein; and
- Direct staff to submit the County of Monterey 2015-2023 Housing Element with related documents to the State Department of Housing and Community Development for certification.

## PROJECT OVERVIEW:

The County is required to update the Housing Element of the General to cover the 2015-2023 period. On July 29, 2015, the Planning Commission conducted a public workshop to review a Public Review Draft of the 2015-2023 Housing Element for the County of Monterey. Staff updated the draft (Exhibit B, Attachment 1) based on comments at the workshop, further research, and comments received from the State Department of Housing and Community Development (HCD) (Exhibit D) and the State of California Public Utilities Commission (Exhibit E).

In addition, an Initial Study and Draft Negative Declaration (Exhibit C) have been prepared in compliance with CEQA. County has received two comment letters, one from the State of California Public Utilities Commission (Exhibit E) and one from the State of California Department of Transportation (Exhibit F). Neither affect the conclusions of the Initial Study.
