Paul Ireland returned my Friday phone call to him early Monday morning. He did not have the DEIR and was unaware of this massive project, Of course I filled him in on the details. He admitted that is it very difficult to evacuate the mouth of the Valley and said the addition of 311 unit would not make it any easier in the event of a flood, earthquake, fire, or something as simple as a bomb scare.

In fact, Before he called me he was talking to Water Resources he said again that they repeated it was not if but when the mouth was flooded again. Of course, I have heard this from Water Resources many times before.

It appears that there is no money or staff to adequately monitor the gauges on the Carmel River. Those of us who are on the advisory committee of CSA 50 rely on the information presented by the County to approve flood control improvements and then recommend that these improvements be implemented. Is the gauges are not maintained, how can we make recommendations? Where is the 100-year flood-plain and what exactly are the various flood events. If you cannot provide this information, how can we properly inform DSA payers what they need to pay for?

I and others have been very disappointed in the Johns and Stokes DEIR for RCV Village. I waiting for a response to my previous e-mail. Cordially, Margaret Robbins
