Brent,

On behalf of the landowners I am putting together a lot line adjustment to resolve an ownership issue between multiple landowners, here is some brief background:

Dennis & Marilyn Noble own APN 424-091-055 (no access of record)
Albert Delgado owns APN 424-091-038 (has access by recorded easement)

The Nobles and Mr. Delgado currently own a common interest in the 160 acre parcel APN 424-091-039 which currently has no access of record and wish to separate their interests by each retaining half (80 acres). In lieu of subdivision, we are seeking to lot line adjust half of the parcel (80 acres) into Mr. Delgado's existing parcel (-038) leaving the remaining 80 acres for the Nobles as shown on the attached Tentative Map.

Mr. Delgado already has access by recorded easement to his parcel (-039) and which will continue have such access subsequent to the LLA. In order to satisfy the requirements of the Monterey County Planning Department to process the LLA, the Nobles are seeking to prefect the written permission they have for access from MCWR and the neighbor Terry Gallagher to provide access to their existing parcel and their new parcel resulting from the LLA.

In summary, Dennis and Marilyn Noble would be the beneficial recipient of the requested access easement as outlined on the attached exhibit map, with rights for utilities if possible.

It is my understanding that you and your wife have purchased Parcel No. 601-256-01 near Lake San Antonio, which borders this District's property:

your access situation.

when this District originally purchased a portion of your lot from Mr. Newburg in 1964, the lot had no access to the County Road. Since the deed is silent on the matter of access to the remaining portion of land, you have the same access as before we acquired part of the property. This is limited to access through our locked gate, along the old county road, and across our property in or near the location shown on Attachment A. This District, of course, cannot give you access across private property, nor will we allow you to trespass across any other portion of District property. Loitering, hunting, camping, or parking of any vehicle or equipment on District property is forbidden.

You have our permission to cut one of the links on the chain now on our gate at Interlake Road and install your own lock. The gate should be kept closed and locked at all times when not in use.

Lake San Antonio has limited access to the water. Should you wish to use the Lake, you must use the Park entrances and comply with the laws and regulations of the Monterey County Parks Department.
