BMAC utilizes a combined roster of Agency Board of Directors (BOD) members and public members for advisory purposes, making recommendations to the Agency BOD for action.

Committee appointees influence decision-making processes at the Agency, and shape the Agency's future. The following criteria will be used to determine eligibility for service on an Agency committee:

- Availability to attend meetings regularly
  - o Three consecutive absences would constitute removal from committee

# SUMMARY/DISCUSSION:

In response to a request from committee members at the May 2, 2018 Basin Management Advisory Committee (BMAC) meeting, staff is providing this update on well permit application activities, which is also provided to the Board of Directors as an information item on a monthly basis.

The Well Permit Application Process is regulated by the Environmental Health Bureau (EHB). The Agency provides technical support to the EHB as part of the process. The changes to the well permit review process that came about since the adoption of the 2010 County General Plan have caused concerns and misinformation in the public. To provide correct and up-to-date information to the public, Agency staff has developed the attached Summary of Well Impact Evaluations (Table).

The Table provides a summation of well permit applications that are being evaluated by Agency staff for compliance with 2010 Monterey County General Plan policies PS-3.3 (domestic wells) or PS-3.4 (high capacity wells), categorized by type of well impact assessment and Salinas Valley subbasin.

In response to requests from the Board of Directors regarding data about construction of wells in the Deep Aquifers, staff has also included a chart depicting the history of well installation in the Deep Aquifers (Figure). This chart, which includes both production and monitoring wells, indicates that a total of forty-five (45) wells have been installed in the Deep Aquifers since 1974, with fourteen (14) of those wells being constructed in the last ten years. An additional ten (10) wells have been proposed for construction in the Deep Aquifers, but construction has not been completed as of the date of this report. Four (4) of the ten (10) proposed wells in the Deep Aquifers have been applied for as "replacement wells" since the Board of Supervisors passed and adopted interim Ordinance No. 5302 on May 22, 2018.
