### Policy

3 The decision of a consumer to seek treatment in a Behavioral Health Bureau program is strictly a 4 5 private matter and outside the realm of legitimate public concern. No one, including news media, has a right to photograph and/or create video and audio recordings of consumers in any programs 6 operated by this Bureau without their consent. This may constitute an invasion of the consumer's 7 privacy. Any taking of photographs or audio/video recordings of consumers of this Bureau by 8 9 anyone is prohibited unless the consumer consents. If at one of this Bureau's facilities, the Program Manager must also consent. 10 11

#### 2 Procedure

A consumer must consent to any photographing or video/audio recording by completing a Consent to Photograph/Video and Audio Recording (Attachment 1). In a case where an individual has a legal guardian/parent or conservator that individual must sign the consent form. That consent will be kept in the consumer's case file.

Behavioral Health Bureau employees should take all reasonable steps under the circumstances to
prevent unauthorized photography and video/audio recording of consumers and should inform
consumers of any possibility that these activities might occur.

Every effort will be made by Bureau staff to encourage photographers, video/audio recording professionals, and consumers wishing to be filmed to conduct their business out of view of any consumers in order to prevent accidental photographing and/or recording of consumers who do not wish to do so.
