Park Parcel P1.2

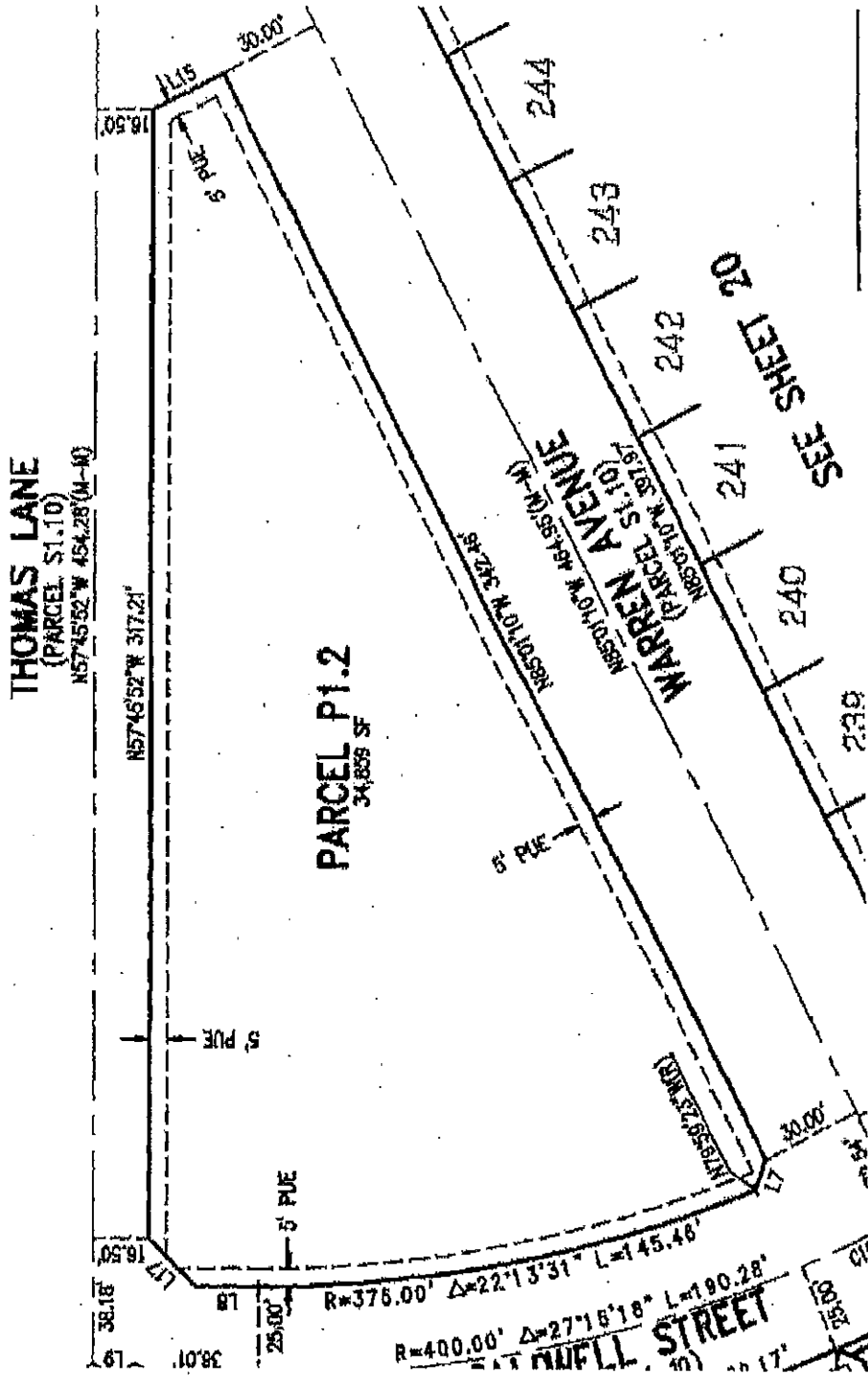




Exhibit A-2 (1 of 2)  
Park Parcel P2.1

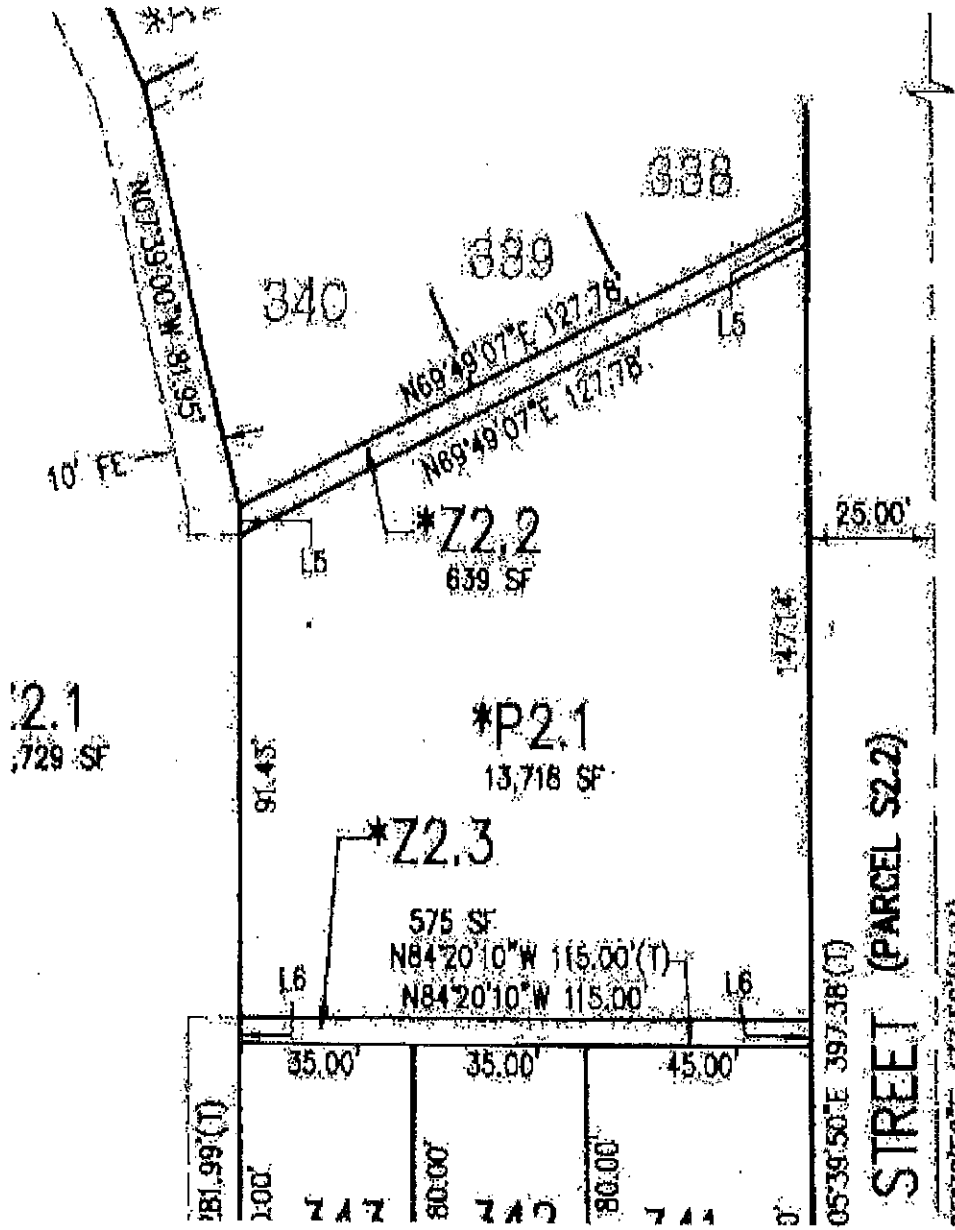
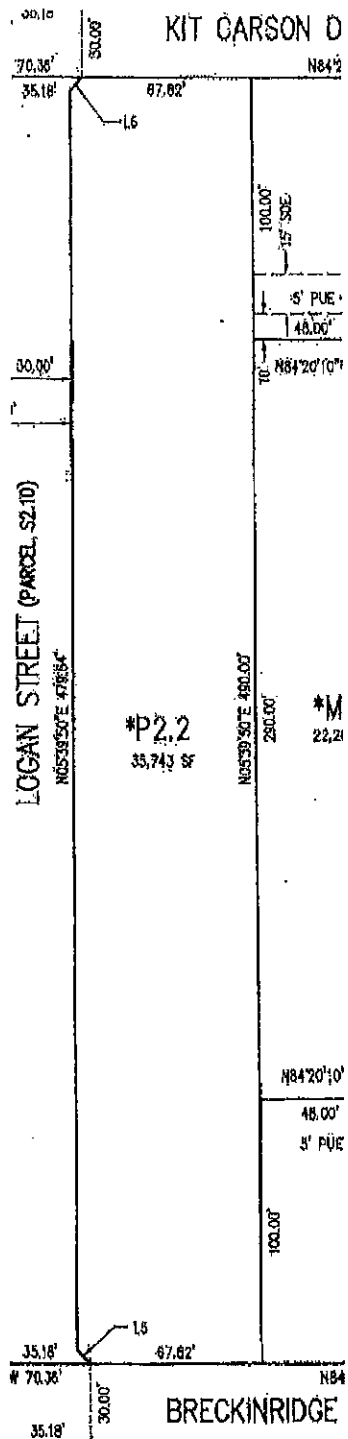
