**ADDENDUM TO LANDOWNER MEMBERSHIP FORM**

This Addendum to Membership Form (“Addendum”) shall addend to and amend that certain Landowner Membership Form (the “Application”) of the undersigned Applicant for membership in the Salinas River Channel Stream Maintenance Program’s River Management Unit Association, Inc., a California Nonprofit Mutual Benefit Corporation, (the “Corporation”).

1. Effective Date. This Addendum shall be effective as of the same date as the Application.
2. Amendment. The Application is amended to include the following acknowledgement, agreement and indemnity provisions:

**Compliance with Laws; Personal Liability; Indemnification.** The undersigned agrees for itself, and for the undersigned’s agents and employees, to comply with all local, federal and state laws in the conducting of the floodplain management and stream maintenance activities on the riverine land(s) parcels listed on the undersigned’s Application (collectively, the “Riverine Lands”). In consideration of the granting of the applied for membership in the Corporation, the undersigned Applicant hereby acknowledges and agrees that under no circumstances shall any Member or Honorary Member of the Corporation, or any officer, official, director, commissioner, member, agent, or employee of any Member or Honorary Member, have any personal liability arising out of their membership in the Corporation, and no Member or Honorary Member shall seek or claim any such personal liability on the part of any of the above. Notwithstanding the foregoing, the undersigned Applicant agrees to the fullest extent permitted under applicable law to indemnify, defend, and hold other Members, Honorary Members, and the Corporation, its officers, directors, representatives, agents, and employees, harmless from and against (i) any claims or liabilities arising out of damage to person or property caused by the negligence or willful misconduct of the undersigned, and/or its agents or employees in the performance of the undersigned’s floodplain management and stream maintenance activities on the Riverine Lands, and (ii) any claims or liabilities arising out of the undersigned and/or its agents or employees failure to comply with all local federal and state laws in conducting floodplain management and stream maintenance activities on the Riverine Lands.

3. Applicability of Addendum. This Addendum shall be added to, and amends, the Application for membership of the undersigned in the Corporation.
