5. Education & Information (20 minutes): Ana Garcia from the Victim/Witness Unit in the DA's office presented on victim silhouettes. She did some research and found many different ways that agencies are utilizing silhouettes. The purpose is for education and awareness. Some agencies include family violence and some really make the silhouette look like the victim at the time the murder occurred. Ana found silhouettes including one of a woman in a wheelchair, some of the shields are the shape of the state, in Oklahoma there is one of a baby carriage to represent a baby shaken to death during a dv incident. Since 2007, we have a total of five male murder victims in Monterey County. Pam Patterson shared the history of the silhouettes: they were originally created and maintained by the Junior League and then passed on to the DVCC. We started with 18 and now have 20. Rancho Cielo made new stands for us and they are willing to continue to do so in the future. Rancho Cielo only charges for the cost of the materials. We have no written guidelines for the creation and use of the silhouettes, so we would like to pursue that in our next meeting.
