#### 10. Old Business

- a) Follow-up on AB2405: E. McCleaf reported she had a representative speak with the presiding Judge Roberts and there is indication that if the Board of Supervisors pass the resolution to allow for the collection of the fees pursuant to 1463.27 PC that he would speak with the other judges about ordering the fees. The full amount allowed may not be ordered and victim advocacy groups should be cautioned to not have any specific expectations of revenue generated by this new source. The next step should be to go back to the original discussion within the DVCC and follow up with what needs to be prepared and what information needs to be provided to the supervisors.
- b) Status of silhouettes: No update, however Sr. Lydia shared that the three silhouettes they recently displayed were well received and viewed by approximately 2,000 people!
