Depending on the outcome of the feedback and analysis it could prompt a more proactive approach to dealing with complaints/issues, such as a toll free number/message line and a multi-disciplinary team (MDT) to meet and discuss findings. A committee may need to be formed to deal with this outside of the regular meeting times.
