Presentation by Sheree Goldman, NP, on the Sexual Assault Response Team (SART),

Coordinator (20 minutes & QA)

- Sheree Goldman has been the program coordinator since 2000, Monterey County Department of Public Health has been overseeing the program since 2007
- Large number of patients have been teenagers recently (12-15 year old age group)
  - o Runaways, met someone online, etc.
  - There is larger number of exams on adolescents in August each year, thought to be due to less supervision while out of school
- Comprised of a multi-disciplinary program to serve children and adults
- Pediatric exams are done at the Child Advocacy center
- Program was started by District Attorney Jeannine Pacioni
- 24hr response community-based program
- Exams are completed at CHOMP & Natividad for adults
- Currently offering evidence collection at home via zoom w/ nurse direction for patients with no physical injuries
- Follow a "Start by believing" outlook, patient centered
- Will examine the suspect and victim, treat all individuals as patients
- Head to toe exam
  - o Completed with an advocate present
  - o Room lighting and alternative lighting to find visible evidence as well as nonvisible fluids
  - o Collect clothing, and take photos of injuries
  - Officers are present for interviews, so the patient doesn't have to repeat their story
  - Lengthy process takes 5-6 hours. Take history -> body exam -> genital exam, both include a camera to take pictures of any injuries, for the internal exam the patient is able to move the small camera around themselves and offered to see their pictures -> offered prophylaxis medication to prevent STI's & pregnancy.
  - The program is funded through Cal Safe to test for many diseases, hospitals write off the costs of other testing, police and MCPHD also finances part of the exams and evidence processing.
  - o Each patient is looked at for strangulation
- Exams are given up to 5 days after
  - Sometimes there are still injuries, but less likely to find DNA, 5 days is farthest out for medications to be effective; except HIV which is only effective up to 72 hours later
- Nurses are wearing highly protective PPE for safety in COVID time, patients are asked to wear masks as well
- Often involved with domestic violence situations. Sexual violence is a crime when married.
- Examiners can go into the court to provide expert info on DV and strangulation
  - o Sent to regular trainings on the danger of strangulation even without visible injuries

- Will ask "Did they put anything across your neck?" rather than using the word strangulation
- Language services are offered at Natividad to help minimize the language barrier to assist in completing the exam process clearly and effectively
- Exam cannot be completed without consent, will need to wait if person is under the influence
- Linda: How are services accessed?
  - Many paths of entry: Monterey County Rape Crisis Center, hospital (hospital staff are mandated reporters even for a competent adult so they must call the police, police will do their due diligence with the information they receive, but exam will be completed whether the person wants to cooperate with law enforcement or not. The hospital point of entry is the least efficient and can take the longest.)
    - Exams without police involvement are called a Non-Investigative Reports. Patients can set up an appointment with a nurse without calling the police.
- Kenya: Question regarding advocate training?
  - Advocates though the MCRCC for advocates include a 40-hour training and continuing monthly trainings
- Linda: Question regarding any connection between Monterey County SART program and the military?
  - Jillian: Every military branch has their own 24/7 programs for sexual assault and they also provide advocacy for every part of the reporting process
  - o Jillian: If her Domestic Violence cases have a sexual assault component they will work with the client in her program. Strictly sexual assault clients will be referred to a different program.
- Christine: Part of the 40-hour DV training includes sexual assault. Similar to sexual assault it is important to believe their story.

COVID Updates and Challenges

• Sheree described the difficulty with teens and maximum screen time. Teens are not wanting to meet with advocates via screen, watch tv, etc. What types of behavioral health services are offered in the school system? Deneen stated that not many schools have a full behavioral health therapist on site, strictly school counselor. Will meet later to

discuss some way to connect behavioral health to schools for students in need of mental health services.

Deneen reported that yesterday MCHD released guidance and FAQ for small learning
pods informing on how many students can participate per pod. Finding safe way for how
small groups of students can stay in small cohorts, have PPE, etc. to minimize exposure.
This would not be for opening schools to regular instruction; but instead for language
therapy, small tutoring session, etc. for students with higher needs. The schools are
working on how to apply the guidance and begin offering services to those who need
them. Will not be approved in the immediate future due to current COVID metrics, but
other counties have started to. Some schools have begun distance learning and had
difficulties, then have had to close again due to the fires (teachers being displaced,
internet connection issues, etc.). Districts are ordering hotspots but are having delays.
