- □ 317 total beds
 - o 4 temporary shelters serving mostly families (DV and non-DV clients)
 - Transitional Housing: Homeward Bound, Lexington Court, Men in Transition (soon to become permanent housing through Section-8), Women in Transition/Hamilton House (includes confidential services for DV survivors)
 - Respite Care: 6 beds funded by the 3 local hospitals for adults in need of short term recuperative care
- Adding new programs in Feb 2020: 15 beds Chinatown (specific population TBD), Working to open: additional new transitional program/micro homes (San Benito county in progress)
- □ Looking to increase DV specific funds from HUD for rental assistance, CalOES for transitional housing funds
- □ Currently receiving HUD, Local, City, & County funding
- □ Utilizing CARS assessment system put in place in 2016 by HUD to prioritize clients based on immediate need
- Discussion regarding the YWCA and Community Homeless Solutions working together to decrease barriers that clients may have to receiving longer term services as well as potential programs for the future
 - Discussion was begun regarding barriers to clients receiving services: Potentially long wait times, limited time and access to services, funding source limits what agencies programs and requirements can look like
